Commission on the Environment Regular Meeting March 22, 2017

Peter Wilk called the meeting to order at 6:05 p.m.

CALL TO ORDER AND ROLL CALL

ORAL COMMUNICATIONS – Kailash Mozumder attended the 3rd Annual State of the San Lorenzo River Symposium Focused on Flow presented by the Coastal Watershed Council. He also attended a presentation by Patrick Robinson at CSUMB about the elephant seals.

Jacques Bertrand attended the Monterey Bay Climate Action Group and the Central Coast Climate Collaborative (4C) who will be hosting a one day event in August. He inquired how the website is updated. Steve Jesberg recommended that the Commission forward the new or updated information to staff with suggested placement on the website and staff will update the site.

Peter Wilk requested an update from staff regarding the Single-Use Plastic and Paper Carryout Bag Reduction Ordinance revision presented by Dennis Norton at the February Workshop. Steve Jesberg stated that Santa Cruz County did not adopt a new ordinance, only began a greater educational outreach and enforcement effort of the existing ordinance. Capitola's ordinance currently meets and exceeds the County's ordinance. Save Our Shores suggested the following modifications to Capitola's ordinance for consideration:

- 1. Section 8.36.020 Paragraph G. Add: "straws" following "knives" in the second line of the paragraph.
- 2. Section 8.36.040 Paragraph A. Add the following sentence to the end of the paragraph: "The recommended fee, based on consumer survey data indicating at what level such a fee would incentivize behavior change, is \$00.25."
- 3. Section 8.36.040 Paragraph B. Add the following language to the end of the sentence: "that is consistent with ASTM D6400 or D6880 and is certified compostable in accordance with the Biodegradable Product Institute certification protocol.

Currently, staff is implementing another educational outreach effort for local businesses. And will be following the success of the County's efforts before recommending amendments to the Capitola ordinance.

Peter Wilk volunteered to follow up with Mr. Norton to ensure his concerns were addressed or if there was something further to review.

1. Introduction of new student member

The Commission unanimously welcomed Isabella Hammond as a student member to the Commission.

2. Presentation of Certificate of Appreciation for Kristin Sullivan

Kristin Sullivan was not present at the meeting. Peter Wilk volunteered to acknowledge Kristin's contributions to the Commission at the upcoming City Council meeting.

1. 2017 Projects

The Commission reviewed the list of actions and projects developed at the February Workshop. The following is the 2017 Work Plan:

- Eco Walk. Pursue the creation of a self-guided tour of Capitola focusing on ecological highlights
 throughout the town. This would include a map, illustrations and background information. The
 goal is to have this plan detailed enough to apply for a "Whale Tail" funding grant.
 Mozumder/Wilk.
- **Peery Park.** Continue efforts on this Soquel Creek restoration project with the goal of getting Fish and Game permission and begin work on the creek banks. Wilk
- **Escalona Creek Restoration.** Pursue whether an effort similar to the Peery park project could be expanded to include this Depot Hill location. Bertrand
- Carpooling Promotion. Pursue the establishment of a rideshare program and parking location. Bertrand
- **HERO Energy savings.** Work with local realtors to determine what might be an acceptable energy savings goal for new and resale housing. The model would be to have something similar to what is in place in San Francisco and Berkeley. Bertrand
- Central Coast Climate Collaboration (4C's). Expand the committee's reach with more active participation in this committee (and perhaps others). Bertrand/Atchison

CITY OF CAPITOLA COMMISSION ON THE ENVIRONMENT PROPOSED ECOTOUR

Version 6-Spring/Summer 2017/COE Edit 5/2017

CONCEPT: Building on the success of the Santa Cruz EcoTour launched summer 2012 (see www.greenwharf.org/EcoTour), the Capitola EcoTour is envisioned as a self-guided, and potentially a limited guided, walking tour that features environmental stewardship and issues unique to Capitola. Eco tourists will access tour information either via brochures distributed at key locations within the City, from smart-phone enabled web content on tour stop signage, guided tour leaders, and via a City website extension dedicated to the tour that contains a printable map of the stops. Each stop on the tour, "GreenSpots," will be identified by branded signage that includes a QR scan tag to enable smart phone users to obtain more information about the particular issue or organization featured at the stop. GreenSpots will feature existing or new interpretive signs mounted at stops. Print and electronic promotion of EcoTour will enable exposure of the tour and its partner organizations and businesses. Estimated expenditures to launch the tour will be offset by grants.

PROPOSED "GREENSPOTS" (stops on EcoTour):

In general, include a beautiful, meaningful environmental quote at each stop...for reflection.

- Capitola Wharf
 - o First stop: What is environmental sustainability (<u>3 E's or 3 P's</u>)? How can we work to make our cities more sustainable for present and future generations of humans and other living organisms with which we share the planet? What action can you take? What is the seventh generation Iroquois philosophy?

"In every deliberation, we must consider the impact on the seventh generation... even if it requires having skin as thick as the bark of a pine." This is an often repeated saying, and most who use it claim that it comes from "The Constitution of the Iroquois Nations: The Great Binding Law."

In fact, the original language is as follows: "In all of your deliberations in the Confederate Council, in your efforts at law making, in all your official acts, self-interest shall be cast into oblivion. Cast not over your shoulder behind you the warnings of the nephews and nieces should they chide you for any error or wrong you may do, but return to the way of the Great Law which is just and right. Look and listen for the welfare of the whole people and have always in view not only the past and present but also the coming generations, even those whose faces are yet beneath the surface of the ground – the unborn of the future Nation."

Oren Lyons, Chief of the Onondaga Nation, writes: "We are looking ahead, as is one of the first mandates given us as chiefs, to make sure and to make every decision that we make relate to the welfare and well-being of the seventh generation to come. ... What about the seventh generation? Where are you taking them? What will they have?"

This program is available for mobile homes, manufactured homes, condos, townhomes, and single-family homes.

This is a limited time opportunity to complete energy and water efficiency upgrades at no cost to you. Grants will be offered on a first-come, first-serve basis and the program will expire once available funding has been depleted.

- ✓ Program is <u>Free</u> to eligible Capitola residents
- ✓ No money down, no repayment requirements
- ✓ Funding offered on first-come, first serve basis

PROGRAM ELIGIBILITY

The program is available to Capitola residents who meets **any** of the following criteria:

- 1) **Senior Citizens**. All persons who are 62 or older and live in Capitola qualify for the program.
- 2) **Disabled Persons**. All disabled persons who reside in Capitola qualify for the program.
- 3) **Income Eligible Households**: Capitola residents whose annual income is at or below the following amounts qualify for the program:
