**BACKGROUND**: The original membership categories for the Commission included one member, who was a resident of the Pacific Cove Mobile Home Park. With the park now closed, staff is recommending removing this membership category with no other changes.

<u>DISCUSSION</u>: Removal of the Pacific Cove Mobile Home Park resident member will leave the Commission with 10 members.

This Commission has proven to be generally united in their recommendations, and staff does not feel it is necessary to maintain the odd-numbered membership for the purpose of tie-breaking votes.

**RECOMMENDED ACTION:** By motion and roll call vote, adopt resolution to amend the FY 2012-2013 general fund budget to accept Target grant revenue of \$3,000 and increase expenditures by \$3,000.

**BACKGROUND**: Each year, Target offers grants to local law enforcement agencies through their Public Safety Grant Program. In 2012, grants were made available to support National Night Out events, crime prevention, training and education, youth programs, or community awareness.

<u>DISCUSSION</u>: The Police Department has two detectives, with a monthly caseload of approximately 20 cases each. On average, between 20% and 30% of these cases involve the collection of evidence stored on cell phones. We currently utilize the services and equipment of the Santa Cruz County Sheriff's Office to perform cell phone examinations to collect and retrieve evidence. It takes approximately 2 to 4 days for the Sheriff's Office to complete the examination process of one cell phone.

The Police Department applied for and was granted \$3,000 from Target for the purchase of a Cellebrite forensic extraction device, which can be used to extract cell phone data. Having a device in our department will allow detectives and patrol officers to access cell phone data within minutes, increasing staff efficiency, crime solvability rates, and the probability of arresting criminal offenders in a timely manner.

**FISCAL IMPACT**: Amend the FY 2012-2013 general fund budget to accept \$3,000 in grant revenue and increase expenditures by \$3,000.

CONSIDER STATUS REPORT ON SPECIAL EVENTS FOR 2012

**RECOMMENDED ACTION**: Accept status report on Special Events for 2012 and provide direction as needed.

**BACKGROUND:** In February 2002, the City Council approved Resolution Number 3202, adopting a Special Event Permit Program and Fee Schedule. The purpose of the program was to provide regulations and guidelines for Special Events occurring within the City limits and to recover costs associated with those events.

Special Events are divided into two categories: General Special Events and Minor Special Events. General Special Events are those with more than 200 attendees or notable impacts to City services or a particular neighborhood and Minor Special Events are events with less than 200 persons and limited impacts.

Minor Special Events can be approved by the City Manager providing the following:

- 1. The event, as proposed, can function safely.
- 2. The event will not cause undue interference with previously approved or ongoing activities, construction, road maintenance, public transit systems, or traffic.
- 3. The event provides a benefit to the City and/or community as a whole that outweighs the limited impacts of the event on the City and/or community.

General Special Events that were not held the previous year must be reviewed by the City Council. Events that were held the prior year may be approved by the City Manager providing the following:

- 1. There are no significant modifications or variations to the event as compared to prior years.
- 2. There were no major issues with the event in recent prior years.
- 3. The event, as proposed, can function safely.
- 4. The event will not cause undue interference with previously approved or ongoing activities, construction, road maintenance, public transit systems, or traffic.
- 5. The event provides a benefit to the City and/or community as a whole that outweighs the impacts of the event on the City and/or the community.

<u>DISCUSSION</u>: In 2012, the Police Department issued a total of 21 Special Event Permits. There were eight General Special Events and 13 Minor Special Events. The General Events included the Wharf to Wharf, Art and Wine, Begonia Festival, Car Show, Motorcycle Show, Jay Moriarity Paddleboard Race, Mermaid Triathlon and Capitola Half Marathon. The Minor Events were Art at the Beach, Twilight Concerts, Movies at the Beach, Easter Egg Hunt, Kite Classic, Surf City Aids Ride, Halloween Parade, Surfing Santa, the Heartland Hospice Holiday Event, three Block Parties and one wedding.

SUBJECT: 2012 SPECIAL EVENTS REPORT

This was the first year the Council did not issue grants for permit fees and personnel costs. The Police Department billed for a total of 177 police personnel hours and 199 public works personnel hours for a total amount of \$24,161. The total for Special Event Permit fees was \$6,688 and an additional \$550 for Lifeguard Services.

In reviewing the After Action Reports for General Events, there were only a few noteworthy changes. The Wharf to Wharf changed the route for the buses for the pick-up of runners from the Pacific Cove Parking Lot. The route was basically reversed and the buses exited SR-1 at Bay Avenue and entered the Pacific Cove Parking Lot from Capitola Avenue. The buses exited the parking lot onto Park Avenue and back onto the highway. There were no significant issues with this change and the streets were reopened about the same time as in years past.

During the Mermaid Triathlon, Park Avenue was closed to through traffic to increase the safety for the bicyclists and spectators. The only issues experienced were a resident on Park Avenue was upset over the closure, but was given a police escort out of the area. The other issue was event staff began playing amplified music before 8:00 a.m. The Police Department made contact with the event management and the music was shut off. Both of these issues will be addressed with the Event Coordinator during the event debriefing.

CONSIDER OPTIONS FOR ADDITIONAL SMOKING REGULATIONS

**RECOMMENDED ACTION**: Accept report and provide direction.

**BACKGROUND:** During its October 11, 2012 meeting, the City Council directed staff to explore additional tobacco policies to address tobacco sales to minors. The City of Capitola uses municipal code section 8.38 to enforce local smoking regulations. The current ordinance, drafted in 1994, and state law does not address reducing illegal tobacco sales to minors.

The Santa Cruz County Tobacco Education Coalition conducted a county wide minor sting operation of tobacco retailers in August 2010. The countywide rate has increased from 17% to 27%; and in Capitola, 18% of the stores surveyed were willing to sell tobacco to a minor (see attached survey report for further details).

<u>DISCUSSION</u>: Due to the significant changes in the state and on the federal level, several California cities and counties have implemented programs to reduce the sales of tobacco-related products to minors in their own jurisdictions.

In California, the State Board of Equalization (BOE) is responsible for the enforcement of tobacco retail sales. Due to reduced funding, the BOE is unable to sustain its enforcement efforts. State laws and the Stop Tobacco Access to Kids Enforcement (STAKE) Act; make it illegal to sell tobacco products to minors. However, the STAKE program can only do annual compliance checks in less than 8% of the stores that sell tobacco. The Food and Drug Administration (FDA) has yet to award a contract to California to enforce illegal sales to minors.

Cities and counties are granted the authority to enact local retail licensing requirements that may include a fee and allow the suspension or revocation of the local license for any tobacco-related law violation through California Business and Professions Code Section 22971.3. Locally, the Cities of Watsonville, Santa Cruz, and the County of Santa Cruz have adopted TRL ordinances.

### Options to explore:

1. Develop a Tobacco Retail License (TRL) ordinance. Locally the cities of Watsonville, Santa Cruz and the County have adopted a TRL. Revenue raised from the license fee can, by state law; only be used to fund enforcement and education efforts directly related to tobacco use. The license fee assessed by other local jurisdictions varies from \$160 in Concord to \$1,550 in Oakland. The City of Capitola has approximately 12 retailers who sell tobacco products. Given Capitola's smaller base of retailers selling tobacco products, the effort necessary to develop, and monitor a new license needs to be weighed against the advantages associated with closer City monitoring of tobacco retailing activity. The City may elect to contract with the Santa Cruz County Public Health Department to provide administration and retailer compliance outreach to reduce tobacco sales to minors. The development of a TRL fee could be used to fund the services provided by the Santa Cruz County Public Health Department.

- 2. Amend the current City ordinance to prohibit smoking in additional outdoor areas. Currently the City's smoking ordinance prohibits smoking in the Village, parks, beach, wharf and City Hall property. Other jurisdictions have adopted ordinances prohibiting smoking in commercial areas that may not be readily accessible to the public; but provides an area that generates second hand smoke such as break areas, porches and patios where drifting smoke becomes a concern.
- 3. Amend our current ordinance to prohibit smoking in additional indoor areas. Currently the City's smoking ordinance prohibits smoking in most commercial locations; however, some jurisdictions have passed ordinances banning smoking in multi-unit housing areas. A smoke-free multi-unit housing ordinance provides protection from drifting smoke and fire hazards for any two apartment complexes, townhouse or condo units sharing a wall.
- 4. Amend our current ordinance to prohibit retailers from selling tobacco products in certain locations. Currently the City's smoking ordinance does not establish limits on locations where tobacco products can be sold. Some jurisdictions have adopted rules making it illegal to sell tobacco products within 1000 feet of public schools and care facilities. Currently there are no retailers selling tobacco products within 1,000 feet of a public school.

## Tobacco sales rate to minors is up!

The countywide rate has increased from 17% to 27% between March 2008 and August 2010; this represents a 60% increase. In Capitola, 18% if the stores surveyed were willing to sell to a minor.

## Local rates rise as statewide rate drops

In 2011, the statewide tobacco sales rate to minors reached a historic low of 5.6%. Though survey methodology varies, the Capitola's rate is 3X higher than the current statewide rate.

### How the survey was conducted

The Santa Cruz County Tobacco Education Coalition collaborated with youth from Reforming Education and Advocating Leadership (REAL). In late August, 2010, underage youth between the ages of 15 and 17 visited 142 stores in all jurisdictions in Santa Cruz County except Scotts Valley. Youth attempted to purchase tobacco products under the concealed supervision of an adult.

## **Quotes from youth**

Here are quotes from youth who conducted the survey:

"It was so easy, most of the time they didn't even bother to ask for an ID – and when they did and I said that I didn't have it, they sold to me anyway."

"Many of us have younger brothers and sisters and we wouldn't want our loved ones to start smoking because they were able to walk down the street and buy cigarettes from our local neighborhood market."

Conceptual Review to consider amending City of Capitola Municipal Code Section 17.27 to permit drive-up window and car service for restaurants in the Community Commercial Zoning District in conjunction with a remodel for the existing

McDonald's restaurant.

**RECOMMENDED ACTION:** No action is required, but staff recommends the City Council discuss the item and provide direction to the applicant.

**BACKGROUND:** The owners of the Capitola McDonald's have approached the City several times over the past few years regarding remodeling the 35 year old restaurant, and requesting the addition of a drive-thru. While a remodel of the structure was encouraged, staff could not support the addition of a drive-thru as the CC (Community Commercial) Zoning District prohibits restaurants with drive-up windows or car service.

**<u>DISCUSSION</u>**: The applicants have submitted a conceptual review application for the City Council to consider an amendment to Municipal Code Section 17.27.060(F) to permit drive-up window and car service for restaurants in the CC (Community Commercial) Zoning District. The CC Zoning Code Section currently reads as follows:

17.27.060 Conditional uses.

The following are conditional uses in a CC district, subject in each case to the securing of a use permit as provided in Chapter 17.60:

F. Lodges, clubs and restaurants, <u>not including restaurants with drive-up windows or car</u> service;

This requires that a property owner secure a Conditional Use Permit for a restaurant use in the CC zoning, but specifically precludes restaurants with drive-up windows or car service. Conditional Use Permit applications are approved by the Planning Commission.

The purpose of the conceptual review application is to provide the applicant with early feed-back and direction on complex projects or policy issues. Feedback may include whether or not the Council would support an amendment to the Zoning Code, and if so, what aspects of the proposal are feasible. Depending upon the feedback, the applicant can follow up the conceptual review process with a formal application to amend the Zoning Code.

There are currently two restaurants with drive-up windows in Capitola, the *Burger King* on 41<sup>st</sup> Avenue, and the *Dairy Queen* on Bay Avenue. The *Burger King* was constructed while under the jurisdiction of Santa Cruz County, and was annexed by the City of Capitola in the early 1980s.

The *Dairy Queen* was likely constructed before the Zoning Code prohibited drive-up windows, and has been grandfathered in as a legal nonconforming use. While the Zoning Code prohibits restaurant drive-up windows in the CC zoning district, it does not prohibit other types of drive-thrus such as banks and pharmacies. There are several banks with drive-up windows within the City, and most recently a drive-up window was approved for the CVS pharmacy located adjacent to the subject McDonald's site. Concerns raised as part of that approval process included potential impacts to adjacent residences, including noise and exhaust from vehicles queuing and making orders.

#### McDonald's Renovation Project Description

McDonald's is also proposing a major interior and exterior remodel that would include elimination of the double mansard roof, and converting the exterior to a more contemporary parapet wall style. The added drive-thru would consist of two queuing lanes to the rear, and would follow along the north side of the structure, exiting adjacent to the existing BevMo located in Capitola Station.

#### Conclusion

The CC zoning applies to property on the 41<sup>st</sup> Avenue corridor and property on Bay Avenue from Highway 1 to Center Street. Of all the locations in the City, these highly travelled roadways are possibly the most appropriate for a drive-thru type of restaurant. However, the character of 41<sup>st</sup> Avenue north of Capitola Road is generally more auto intensive than 41<sup>st</sup> Avenue south of Capitola Road and the Bay Avenue corridor. If you recall, a 41<sup>st</sup> Avenue Corridor Economic Development/Mixed Use Revitalization Study was prepared in 2009 that described the 41<sup>st</sup> Avenue corridor as a range of different existing land uses, various adjacent land uses, and different forms of access to the regional transportation network. The study recommended that the City consider a block by block vision of 41<sup>st</sup> Avenue that could encourage the development of various districts in appropriate locations. If the Council were to support the concept of allowing drive-up windows for restaurants, it would be recommended that the amendment to the CC zoning district be written in a way that limits restaurant drive-thrus to specific areas of the CC district, such as the 41<sup>st</sup> Avenue corridor north of Capitola Road.

General issues that arise from drive-thru restaurants include increased traffic, and potential impacts to adjacent residential districts including noise and exhaust from vehicles queuing and making orders. If the City Council is inclined to support an amendment to allow drive-up windows in the CC zoning, there are two ways that this could be accomplished. The applicant could submit a formal application to amend the Zoning Ordinance in conjunction with the McDonald's remodel, or the amendment could be included in the overhaul of the Zoning Ordinance as part of the overall General Plan update.

**FISCAL IMPACT**: The exact fiscal impact is unknown. Potential economic benefits to the City could include increased sales tax from increased sales due to restaurants being able to accommodate more customers.




PROPOSED LEFT (DRIVE THRU) ELEVATION
