WRITTEN AND ORAL COMMUNICATIONS

Staff suggested discussing work items to the end of the agenda.

OTHER BUSINESS

- 1. The minutes of May 8, 2019 were approved (Keet/Wilk)
- 2. Introduction of new student commissioner Bryce Ebrahimian.

Bryce commented he is a student at Monte Vista Christian, and currently working as an intern for Congressman Jimmy Panetta. Bryce became a member of the COE to contribute to the community by gaining a greater understanding of effectively managing a health and sustainability of the environment on a local level.

3. Discussion of the Single-Use Plastic and Paper Carryout Bag Reduction Ordinance and Environmentally Acceptable Packaging Materials Ordinance.

Larry Laurent, Assistant to the City Manager, provided the Commission with an overview of the city's ordinances and emphasized enforcement is done on a complaint basis; compliance is typically met by education rather than fines.

Peter Wilk and Meredith Keet agreed to review the city ordinances and draft a plan to increase enforcement efforts.

Bryce Ebrahimian suggested utilizing social media to communicate messaging about Wish-Cycling.

ITEMS FOR NEXT AGENDA AND WORK PLAN STATUS

Soquel Creek/Peery Park Riparian Restoration

There are funds for proceeding with Phase 2 work in Peery Park. George McMenamin will be working with the restoration crew at the end of September through the beginning of October to continue invasive vegetation removal, erosion control installation and ongoing maintenance of the Phase 1 areas.

Future work in the area between Peery Park and Redtree riparian area will require a proposal from Mr. McMenamin, modification to the Fish & Wildlife permit and permission from Santa Cruz County Sanitation District.

- Native Milkweed Campaign/Monarch Protection and Preservation
- Cathlin Atchison suggested the Commission review AB 2421 Wildlife Conservation Board: Monarch Butterfly and Pollinator Rescue Program along with the grant program information. Staff recommended the COE identify a specific project that may meet the grant guidelines.
- Sustainability Guidance for Events in Capitola

Staff requested the COE submit ideas on creating a guidance document for organizations/groups that put events on in Capitola regarding: reducing waste and reducing and eliminating single use plastics. Staff will draft a document for the COE for consideration at the November 13th meeting.

Sustainable Guidelines for Events in Capitola

Purpose

These are sustainability guidelines are intended to provide event coordinators and groups that organize events in Capitola recommendations to eliminate single use plastics, reduce waste, collect all trash from events, promote recycling and reuse.

Guidance

- Provide one trash can and one recycling can for each _____ person(s) in attendance. Monitor
 trash and recycling cans to inform attendees of what can and cannot be recycled, ensure
 correct placement in designated receptacles;
- Eliminate the use of all plastic water/soda bottles, straws, cups, utensils, plates, to-go containers, bags of all sized, beverage stir sticks, balloons;
- Use compostable, plant-based to-go ware that meets the acceptable specifications for composting;
- Promote BYO bags, bottles, to-go ware. Encourage event vendors to offer discounts or other benefits for customers who bring their own;
- Encourage event coordinators to set-up hydration stations for attendees to bring their own water bottles;
- Consider "Green" certification of events or of specific vendors
