Please refer to code of Civil Procedure §1094.6 to determine how to calculate when a decision becomes "final." Please be advised that in most instances the decision become "final" upon the City Council's announcement of its decision at the completion of the public

SUBJECT: Opposition to California Redistricting Commission Proposed Assembly

Redistricting Map

<u>RECOMMENDED ACTION</u>: Authorize the Mayor to sign a letter to the California Redistricting Commission to keep the Monterey Bay region in a single Assembly District.

<u>BACKGROUND</u>: On November 10, 2021, the California Citizens Redistricting Commission released draft Congressional, Assembly, and Senate legislative redistricting maps for the state of California.

The preliminary redistricting maps divide the Monterey Bay area into two separate Assembly Districts, splitting Santa Cruz City from the rest of the cities in Monterey Bay area. Prior draft maps also excluded the City of Santa Cruz from the Senate and Congressional districts for the Monterey Bay Area. Fortunately, this was rectified, and unified Senate and Congressional districts appeared in the maps updated on November 10, 2021.

<u>DISCUSSION</u>: It is critically important that our region maintains a strong unified voice in the decision-making that impacts one of our greatest natural treasures, the Monterey Bay. The preliminary map diminishes the region's influence for this resource that is so vital to our community

The region has been fortunate to have representatives that have long worked for the preservation of the Monterey Bay. We have had a history of working as a unified region to preserve our natural environment. Further, the region shares air, ocean, power, and transportation resources and must have unified representation supporting our community of interest. Splitting the Assembly District that represents the Monterey Bay, or reverting to a map that would remove the City of Santa Cruz from the Congressional and Senate Districts, would only make advocating for the Monterey Bay area more difficult.

The Commission is now taking public comment on the preliminary maps. To ensure that Capitola's input is fully considered by the Redistricting Commission the letter should be sent by November 19, 2021.

**Dear Commissioners:** 

On behalf of the City of Capitola, I write with an urgent call to ensure a unified Monterey Bay Community of Interest in the final redistricting maps for the state of California.

The preliminary Assembly redistricting map released on November 10th divides the Monterey Bay Area into two separate Assembly districts, splitting the representation for the Monterey Bay Area. Prior maps also excluded the City of Santa Cruz from the Senate and Congressional districts representing other cities in the Monterey Bay Area.

It is critically important that our region maintains a strong unified voice in the decision-making that impacts one of our greatest natural treasures, the Monterey Bay. The preliminary map diminishes the region's influence and advocacy for this resource that is so vital to our community.

The region has been fortunate to have representatives that have long fought for the preservation of the Monterey Bay. We have had a long history of working with the City of Santa Cruz to preserve our natural environment. Further, the region shares air, ocean, power, and transportation resources and must have unified representation supporting our community of interest. Splitting the Assembly District that represents the Monterey Bay, or reverting to a map that would remove the City of Santa Cruz from the Congressional and Senate Districts, would only make advocating for the Monterey Bay area more difficult.

The City of Capitola strongly opposes the draft Assembly map, and we urge the Commission to draw new districts that ensure that all cities that share the Monterey Bay remain in the same Assembly, Congressional, and Senate Districts.
