





BACKGROUND

The Art at the Beach was held on four (4) Sunday's this summer. There was no music for the second year in a row, however the artists were very pleased.

Leslie Fellows have served as the Program Coordinator, an independent contractor, for the Art at the Beach event for the past 17 years. At the conclusion of this season Leslie announced her retirement from the position. The Art at the Beach Program Coordinator had been compensated at a rate of \$300 per show and space commission for the number of booths at each show.

The February 2023 meeting the Commission moved to create a subcommittee to revision the Art at the Beach event.

DISCUSSION

Leslie Fellows in email correspondence with Staff has offered to modify her role for one more year and four more shows the summer of 2023. The modification, outlined in Attachment 1, details her responsibilities focused on the pre-event coordination and would require someone to take on the day of responsibilities. The 22/23 Fiscal Year has \$2,000 budgeted for this event coordinator payment and there is \$830 remaining.

The timing of event planning requires event coordination to begin as soon as possible in order to conduct a successful event.

Scope of Services


The Consultant shall act as Program Coordinator of the Sunday Art at the Beach event for the Capitola Art & Cultural Commission.

The duties of the Program Coordinator are as follows:

1. Act as a liaison between the Capitola Art & Cultural Commission, city staff, the artists

- 2. Conduct marketing activities sufficient to attract artists to fill the available booth spaces.
- 3. Review artwork and select artists based on the Art & Cultural Commission criteria
- 4. Review artist application and assign booth space.
- 5. Create a diverse booth assignment and balance of artists participating in each show.
- 6. Promote and publicize the event in local and regional media to attract visitors/buyers.
- 7. Collect booth fees using the rates set by the Art & Cultural Commission prior to the event.
- 8. Work with City Staff to secure presence of a qualified individual each Sunday of the event to assist artists, oversee the event and be the liaison as needed with the Capitola Police Department.
- 9. Monitor the activities of artists to assure compliance with the City's policies.
- 10. Transmit to the City event reports listing the number and size of booths rented; participating artists; revenues collected and estimated number of visitors, at the conclusion of each show.
- 11. Prepare a year-end report summarizing the event for the Art & Cultural Commission including an evaluation of how well the event met the commission's objectives and any suggestions for improvement.

SUBJECT: Fallen Tree in Lower Beach and Village Lot Art Proposal

RECOMMENDED ACTION: Receive art proposal from Anthony May and provide direction.

BACKGROUND: During the 2019-2020 winter storms, a very large cypress tree fell in the Lower Beach and Village Parking lot. Most of the tree was removed, however the stump remains in place.

Commissioner Mozumder is the chair of the subcommittee looking at this as a public art project. The first call to artists closed on June 27th. The commission decided to conduct a second request for proposal which closed on October 4, 2023. The subcommittee reviewed all submission and presented to the Commission at the February 2023 meeting. The Commission moved to reach out to Anthony May for an installation proposal.

Subcommittee consists of Commissioner Mozumder and Commissioner Cahalen

DISCUSSION

Staff contacted Anthony May to request an installation proposal. Anthony May resides in Oregan and the \$250 stipend did not allow for travel in addition to proposal materials. Anthony will conduct the proposal presentation via zoom.


The project budget is \$5,500 which is from the Public Art Fund.

See Level




This fallen Cypress represents one of many place-markers for storms and subsequent flooding of recent years across California and Capitola. Erosion of land under this tree from its crest atop a ridge-line is a telltale sign of the current state of Earth in flux. Engulfed by sudden and frequent changes in landscapes, waterlines and reality, humans are evermore becoming aware of a changing world that is not independent of human action. Inasmuch, a result of inaction concerning eco-awareness and eco-pedagogies. My intention is to inform through a particular aesthetic, reflection of catastrophic events articulated by shifts in collective living spaces.

See Level is a play on words meant to derive land-spatial measurement. An intentional malapropism of the word sea for see provokes gameplay for the reader to look at the sculpture as a puzzle. Sea levels are the imaginary lines from which land above/below tides fluctuates. See Level is an eye-line for seeing; it is the level at which eyes read spaces surrounding them.


The images within this proposal illustrate my intent to create a physical composition using remnants of the Cypress tree stump as a base for sculpture. The public installations of art I create involve an empirical process of (re)construction that responds to the environment. Mine is an in-situ process, and so I cannot portray exactly what will develop. My sketch mock-up offers a variation of design for my aims in creating sculpture for the Tree Stump Art Project.


Whenever possible I use material taken from fallen, dead and dying trees in the creation of my public art. Only the stump from this Cypress tree remains so I plan to seek local parks services for possible materials from other Cypress trees in the area removed through stewardship of civic and park spaces. I will then graft that material onto the stump base to appear as if the wood cubes of material came naturally from the tree stump. The material can also be replaced by other species of trees similar to Cypress such as cedar, etc. and/or lumber. The creation and build is determined by what material is available for integration into the final composition.



Each armature of cubed wood blocks is attached into the base of tree trunk using 1/2" or 3/8" rebar with tested true structural integrity. The rebar is then shaped as it comes out of the trunk base to interweave itself in space and in new orientation from its "original growth" patten in a rearrangement of form, and time, recorded in tree growth.

The external and natural organic form created by the tree trunk, including bark, will be preserved so the sculpture can maintain various elements of organic and natural lines within the geometric and angular constructs of gridded cubes.





Cavernous design allows for the interior of sculpture to be seen, while illustrating it as offset by the geometric grid. The artificial decomposition from inside the tree trunk appears enacted by technological platforms as suggest by sieving of the grid. In this way the piece appears as if rotted by an unnatural process where block pieces are pulled from its natural core into space as a flow of material in wind, water or storm; fragments in dissolve by human mechanism.



One of the main points of interest for creating this sculpture is the surrounding area on location of the Tree Stump Project. The flora allows the trunk appear as if it is underwater. In this way the sculpture also appears to be submerged, with armatures of material in ebb and flow away from the piece in a pulling of the tide or by wave energy. See Level functions as a past/present/future state of the conditions of environmental change where parts of land above water are engulfed/submerged by water. The Juan de Fuca line dotting the underbelly of West Coast Pacific Rim of North America provides a broken contour, affecting the sea level average there.

Project Timeline

My proposal is supported by various public art sculptures I have successfully realized and installed in several locations across North America. Please see a small sampling of these works in the following pages of proposal. Through established techniques and without unforeseen issues during the process of creating my sculpture, I propose a maximum of two weeks of stay in Capitola for the development and installation for the Tree Stump Art Project.

In past experiences of similar public artworks, commissioning agencies were able to offer housing, travel and vehicle compensation, alongside workspace throughout the creation of my work (to offset costs that would otherwise come from the commission stipend). I have been in touch with a local maker's space called IdeaFab Labs who were supportive of me using their facilities for the preparation of material for sculpture, so I have located a workspace if my proposal is selected and approved for installation. I will seek to connect with Capitola parks services to gather dead/removed Cypress material local to the area and/or other suitable trunk/ lumber material mentioned earlier. In the occasion that the Capitola art committee and council does not have community access to accommodations (i.e. hotel/private stay, etc.) for art commission, is unable to offer local transportation/travel compensation, the artist commission fee can help secure external costs for my stay and needs in the creation of proposed sculpture for the City of Capitola. Thank you for your time, generous support, and consideration.





BACKGROUND

The Commission approved a subcommittee to work on a Public Art for the Begonia festival and choose the park next to Soquel Creek by Stockton Ave as the location. Recommended Action: Discuss and Provide Direction

BACKGROUND The Monterey Avenue Railing project was approved as a project by the Commission prior to March 2020. The project was delayed due to the onset of the COVID-19 pandemic. Original project budget was \$100,000 from the Public Art Fund however the Commission decided to reduce the budget to \$50,000 due to balance of the Public Art fund is \$171,000. Commercial building projects over \$250,000 generally contribute 1% of the project valuation to the public art fund. In 2021-2022 only one project had to contribute to the fund (\$5,000) and the City is still experiencing recovery from the pandemic in this regard.

Chair Johnson is the chair of the subcommittee with Commissioner Mozumder and Commissioner Cahalen.

DISCUSSION

A Call to Artists, was released on March 3, 2023, for the project. Staff received correspondence from members of the public which are Attachment 1, 2 & 3.

<u>FISCAL IMPACT</u> The budget is \$50,000 from the Public Art Fund. The current balance of the Public Art fund is approximately \$171,667. The Commission currently have \$25,500 committed to projects in addition to this budget.

Hello Nicki,

I looked at the RFQ for the Monterey Railing art project and I am a bit disappointed to see what the

Art and Cultural Commission is expecting to get for a \$50,000 budget.

There are about 1,458 sf of railing surface to be covered to look like one piece which comes to about \$34.50 per sf. Considering the cost of liability insurance, design, manufacturing, transportation and installation of 94 panels, there is no money left to get metal materials.

The current market prices for such public art projects range between \$100 to \$200+ per SF.

I installed a very similar project in Milpitas, CA that is 360 sf. for a budget of \$100,000.

The \$50,000 budget would allow for about \$532 per panel or about 6 sf of artwork.

Please bring this to the attention of the Art and Cultural Commission to possibly review the RFQ to call for a reasonable design and art size to fit the \$50,000 budget.

Hi Nikki,

Having lived for 11 years in downtown Santa Cruz, I got excited when I saw the call for railing art along Monterey Ave. Then I read what was being asked for.

To put 625-feet x 42" (for code) means that the budget is less than \$25/sq.ft. (or \$81/running foot). That is a pittance for even the city to build as a simple code-abiding railing.

As a landscape architect, I was using \$100 a running foot for railings back 25 years ago.

It certainly leaves no room for it to be engineered or installed.

Who decided this budget?

I suggest you offer that the engineering for this project come out of the City's building department at the very least, which will save the artist at least \$4k.

Good luck with this project.



Dear Ms. Bryant,

In your call for artists for the Monterey Avenue Railing project you refer to weathering steel as "Core 10." I have never seen weathering steel written in that fashion. It should probably say corten, or cor-ten, both of which are the genericized trademarks (like kleenex or jello, brand names that became common usage for the products) for weathering steel. Forgive my interference, but I believed you would want to know.

You may wish to reconsider making weathering steel an option, however, since it is very likely to stain the concrete underneath the railing in a way that would not be pleasing. Also, in a marine environment there are other disadvantages you can read about online.

SUBJECT: Arts Council Santa Cruz County Liaison

RECOMMENDED ACTION: Select a liaison to sit on the Arts Council Santa Cruz County

BACKGROUND

Since its founding, each of the five jurisdictions in Santa Cruz County has appointed a representative to serve as a liaison to the Arts Council, usually an elected representative of their governing body. Liaisons are invited to be as engaged in the Arts Council's work as they would like. Most often, the Arts Council Executive Director and a board member meet once a year with the liaison to discuss needs and opportunities in their jurisdiction, and to provide an update on the Arts Council's plans for the upcoming year.
