Mayor Bertrand called the meeting to order at 7 p.m.

1. ROLL CALL AND PLEDGE OF ALLEGIANCE

Council Member Yvette Brooks: Present, Council Member Ed Bottorff: Absent, Council Member Sam Storey: Present, Vice Mayor Kristen Petersen: Present, Mayor Jacques Bertrand: Present.

2. PRESENTATIONS

A. Introduce New Police Officer

Police Chief Terry McManus introduced Michael Kilroy, the department's newest police officer. A veteran policeman with 20 years' experience working in Phoenix, Officer Kilroy praised his fellow officers' skills and expressed his pleasure joining the department.

5. PUBLIC COMMENTS

Carin Hanna, Capitola Village and Wharf Business Improvement Association (BIA), shared that at its last directors meeting, the BIA voted to invite Council Member Kristen Petersen to be the board liaison, and she has accepted.

Melinda Vento, Topaz Street resident, thanked the City for its efforts addressing traffic concerns.

6. CITY COUNCIL / STAFF COMMENTS

Council Member Brooks volunteered recently at the Live Oak Senior Resource Center helping to feed seniors lunch. She invited the community to participate Mondays, Wednesdays, and Fridays at noon and added Community Bridges also needs drivers for Meals on Wheels. She visited the Museum of Art and History's new exhibit on seniors in the community and distributed information. She and Council Member Petersen also attended the county census launch.

Council Member Petersen invited the community to a public forum on April 17 at the Community Foundation regarding the Community Action Board community action plan.

Council Member Storey announced that the Police Officers Association will sponsor "Skatetola" at the Monte Family Skate park on May 11. The Art and Cultural Commission will formally unveil the new public art mural then. He also asked for a follow-up report on traffic calming efforts in the Jewel Box.

Mayor Bertrand also recently joined in on Meals on Wheels delivery and was surprised to find he knew many recipients. He also encouraged community engagement.

City Manager Jamie Goldstein announced the California Coastal Commission approved jetty and plume permits yesterday and invited the community on April 20 to the "fastest Easter egg hunt in the west."

City Manager Goldstein introduced Partnership Specialist Tory Del Favro of the Census Bureau. She noted California is a "giver not getter" for federal funding and explained that census self-response will be available on the internet starting in March 2020. In early outreach, officials have been hearing a mistrust of the federal government, which creates the need for local emphasis on the importance of everyone participating in the census to get a full and accurate count.

She introduced "census celebrity" Vince Baraba, a Capitola resident, who worked on censuses under two administrations. He provided background and acknowledged the concerns around a potential citizenship question. He emphasized that census information is protected by Title 17 with severe penalties for disclosure and the bureau has never released individuals' information.

Police Captain Andrew Dally presented the staff report. The proposed ordinance will remove the complete prohibition of retail sales and update language. Staff responded to a question noting that recent state law does not allow cities to prohibit delivery, but that directive has been challenged. It will continue to follow the issue.

D. Introduce Revised Zoning Code for Coastal Commission Certification <u>RECOMMENDED ACTION</u>: Accept staff presentation, provide direction on revised code, and direct staff to initiate public review.

Council Member Storey noted that he needs to recuse himself from discussion of issues related to the Monarch Cove Inn due to his home's proximity. Council Member Petersen noted a similar conflict with the Village Hotel discussion. Each left the dais when those items were covered.

Community Development Director Katie Herlihy presented the staff report. She emphasized that comments and requested changes are from Coastal Commission staff and the update has not gone to the commission itself. This update does not include geological hazards and non-conforming property to allow more time to address new coastal policies. She highlighted eight areas for discussion:

- 1. New Brighton State Beach
- 2. Monarch Cove Inn
- 3. Environmentally Sensitive Habitat Areas
- 4. Village parking
- 5. Village hotel
- 6. Accessory dwelling units
- 7. Density versus floor area ratio
- 8. Garage exception

Public comment was provided by the following:

Lonna and Bob Blodgett, Monarch Cove Inn owners, noted previous action removing residential rights and asked for R-1 zoning of their property.

Adam Samuels, Depot Hill resident, supports residential use for the Monarch Cove property.

TJ Welch, Depot Hill resident and Planning Commissioner, supports a request for more time to make a decision.

Mike Morrissey, Depot Hill resident, followed up on his public comment letter addressing potential overstepping by the Coastal Commission.

Nels Westman, resident, shared his alarm regarding the Coastal Commission's sea level rise policy of "managed retreat" that he feels will have immediate and devastating impacts. He wants the Council to decide on whether low-lying areas may rebuild and carry on or not and advocated for specialized legal support.

Carin Hanna echoed these concerns as a property owner on both the river and in the Village, urging caution and taking time to understand the issues.

There was significant discussion about how to address competing concerns of public use and neighborhood preservation on Depot Hill, as well as legal issues, including the option of hiring a coastal specialist firm. The council supported continuing the item to allow more research and discussion initially for Monarch Cove in a motion by Council Member Petersen, seconded by Mayor Bertrand, and then later for the entire update.

SUBJECT: Second Reading of an Ordinance Amending Chapter 9 of the Capitola Municipal Code Pertaining to Cannabis

<u>RECOMMENDED ACTION</u>: Adopt an Ordinance to amend Chapter 9.61, Cannabis Sales, Processing and Cultivation, to remove the prohibition on retail sales and update the section to reference the required retail cannabis permit (Chapter 5.36) and conditional use permit (17.24.020.D.1b).

<u>BACKGROUND</u>: In 2014 the City passed Ordinance No. 989 which banned commercial cannabis activity in the City. Following the passage of Proposition 64 in 2016 the City Council amended that ordinance and directed staff to review options to regulate commercial cannabis activity. On July 26, 2018, the City Council adopted Ordinance No. 1021 adding Capitola Municipal Code (CMC) Chapter 5.36: Retail Cannabis Licenses, establishing a licensing structure for two cannabis retail permits and amending CMC Section 17.24.020 to authorize retail cannabis sales in the RC (Regional Commercial Zoning District). The ordinance was written to only become effective upon the certification of the passage of a tax for retail cannabis sales by voters.

In the November 2018 General Municipal Election, Capitola residents passed Measure I authorizing a retail tax on cannabis sales. On December 13, 2018, Council adopted Resolution No. 4136; certifying the election results and enacting Ordinance No. 1023 for a cannabis tax and approving Ordinance No. 1021 establishing a process for retail sales of cannabis in the RC district. The cannabis tax took full effect on January 1, 2019.

<u>DISCUSSION</u>: The City's original prohibition on commercial cannabis activity is codified in CMC Chapter 9.61: Marijuana Sales, Processing, and Cultivation. Specifically, it prohibits all indoor and outdoor cultivation of marijuana except in compliance with the Compassionate Use Act; possession, use, and cultivation in accordance with the Adult Use of Marijuana Act (AUMA or Proposition 64), and testing facilities that do not involve other prohibited activities. All other commercial marijuana activities are expressly prohibited in Chapter 9.61.

The proposed Ordinance amends CMC Chapter 9.61 to make it consistent with the voterapproved Chapter 5.36 and 17.24.020, updating the language to prohibit any business or premise to sell cannabis, whether medical (medicinal) or adult use (recreational) within the City of Capitola <u>unless</u> the business holds both a Capitola Retail Cannabis License (Capitola Second Reading Ordinance Update Chapter 9 April 25, 2019

Municipal Code 5.36.030) and a Conditional Use Permit for Retail Cannabis Establishments (Capitola Municipal Code 17.24.020.D.1.b.). The amended language changes the term "marijuana" to "cannabis," creating consistency within the Municipal Code while following State guidelines related to proper and legal terminology. It also removes redundant language regarding the personal possession, use, and cultivation of recreational marijuana in accordance with AUMA, which became law in November 2016.

The City Council approved the first reading at its April 11, 2019, meeting.

ORDINANCE NO.

AN ORDINANCE OF THE CITY OF CAPITOLA REGARDING CANNABIS SALES, PROCESSING AND CULTIVATION

THE CITY COUNCIL OF THE CITY OF CAPITOLA DOES ORDAIN AS FOLLOWS:

Section 1: Chapter 9.61 of the Capitola Municipal Code is hereby amended to read as follows:

9.61.010 Findings

The City Council of the City makes the following findings:

A. In 1996, the voters of the State of California approved Proposition 215, also known as the Compassionate Use Act (CUA), codified at California Health and Safety Code section 11362.5 et seq.

B. On January 1, 2004, S.B. 240, known as the "Medical Marijuana Program" (MMP) (codified at Health and Safety Code section 11362.7 through 11362.83) went into effect to clarify the scope of the CUA.

C. On January 9, 2014, the City Council adopted Ordinance No. 989 to regulate the processing and cultivation of medical marijuana.

D. On November 8, 2016, California voters approved the Control, Regulate, and Tax Adult Use of Marijuana Act (AUMA), which became effective immediately. Among other things, AUMA decriminalizes under state law the possession, use, transport, and purchase of limited amounts of non-medical marijuana for individuals who are 21 years of age or older. AUMA decriminalizes under state law the planting, cultivation, harvesting, drying, and processing ("cultivation activities") of up to six marijuana plants in, or upon the grounds of, a private residence, but at the same time permits local jurisdictions to enact and enforce reasonable regulations to regulate indoor cultivation activities and to completely prohibit cultivation activities outdoors upon the grounds of a private residences until the California Attorney General determines that non-medical use of marijuana is lawful in the State under federal law.

E. To regulate commercial use of marijuana, the AUMA added Division 10 (Marijuana) to the Business and Professions Code, which grants state agencies "the exclusive authority to create, issue, renew, discipline, suspend or revoke" licenses for businesses including the transportation, storage, distribution, sale, cultivation, manufacturing, and testing of marijuana.

F. The AUMA authorizes cities to completely prohibit the establishment or operation of any marijuana business licensed under Division 10 within its jurisdiction including marijuana dispensaries, marijuana retailers, and marijuana delivery services. Absent appropriate local regulation authorized by the AUMA, state regulations will control marijuana activities.

G. Cannabis activities can create negative impacts relating to overall health, safety, and wellbeing of City residents. To the extent allowed by California law, a prohibition of commercial marijuana processing and cultivation is necessary to avoid the risks of adverse health effects, criminal activity, loitering, offensive odors, indoor structural damage, and electrical fire hazards that may result from such activities. H. On November 6, 2018, Capitola residents passed a ballot measure authorizing the establishment of a tax on retail cannabis sales. Ordinance No. 1023 establishing a cannabis tax was considered adopted on December 13, 2018, the date the City Council adopted Resolution No. 4136 certifying the November 6, 2018, General Municipal Election.

I. On December 13, 2018, Ordinance No. 1021 became effective, adding Chapter 5.36 Retail Cannabis Licenses establishing a licensing structure for cannabis retail businesses and amending Chapter 17.24 "Commercial and Industrial Zoning Districts" section 17.24.020 to authorize retail cannabis sales in the CR (Regional Commercial) zoning district.

9.61.020 Purpose and Intent

A. It is the purpose and intent of this chapter to promote the health, safety, and general welfare of the residents and businesses within the City by regulating the sales, cultivation and processing of cannabis

B. Nothing in this chapter shall be construed to (1) allow persons to engage in conduct that endangers others or causes a public nuisance, or (2) allow any activity relating to the cultivation, processing, or distribution of cannabis marijuana that is illegal under state or federal law.

9.61.030 Definitions

For purposes of this chapter, the following definitions shall apply:

A. "Collective or cooperative cultivation" means the association within California of qualified patients, persons with valid identification cards, and designated primary caregivers to cultivate marijuana for medical purposes as defined in strict accordance with California Health and Safety Code sections 11362.5 et seq.

B. "Commercial cannabis activity" includes the cultivation, manufacturing, processing, packaging, distribution, and sale of cannabis and cannabis products.

C. "Cultivate" or "cultivation" is the planting, growing, harvesting, drying, processing, or storage of one or more cannabis plants or any part thereof in any location.

D. "Medical cannabis" is defined in strict accordance with California Health and Safety Code sections 11362.5 et seq.

E. "Processing" is defined as any method used to prepare cannabis or its byproducts for commercial sale, including but not limited to: drying, cleaning, curing, packaging, and extraction of active ingredients to create cannabis related products and concentrates.

F. "Primary caregiver" is defined in strict accordance with California Health and Safety Code section 11362.5 et seq.

9.61.040 Prohibited activities.

A. Indoor and outdoor cultivation of cannabis is prohibited in all areas of the City, except as outlined below in Section 9.61.040(A)(1).

1. Cannabis for personal use may be cultivated in conformance with the following standards:

(a) An individual may cultivate cannabis indoors on the parcel where the individual resides. Outdoor cultivation is prohibited.

(b) A primary caregiver may cultivate medical cannabis indoors for a qualified patient for whom he/she is the primary caregiver. Outdoor cultivation is prohibited.

(c) Cannabis cultivation is permitted only on parcels with residential units. Cannabis cultivation is permitted only within a residential unit, a garage, or a selfcontained outside accessory building that is secured, locked, and fully enclosed.

(d) The cannabis cultivation area shall not exceed a total of six plants per residence or property (for example, a property owner/resident may not grow six plants indoors and grow additional plants in a separate self-contained building on the property).

(e) The use of gas products (CO2, butane, etc.) for cannabis cultivation or processing is prohibited.

(f) Cannabis cultivation for sale is prohibited. Notwithstanding this prohibition, a primary caregiver may recover from his or her qualified patient the actual costs incurred by the primary caregiver in cultivating the medical cannabis he or she delivers to the qualified patient.

(g) From the public right-of-way, there shall be no exterior evidence of cannabis cultivation.

(h) The residence shall maintain kitchens, bathrooms, and primary bedrooms for their intended use and these rooms shall not be used for cannabis cultivation.

(i) Any cannabis cultivation area located within a residence shall not create a humidity, mold or other nuisance condition.

(j) The cannabis cultivation area shall not adversely affect the health or safety of the nearby residents by creating dust, glare, excessive light, heat, noise, noxious gasses, odor, smoke, traffic, vibration, or other impacts, and shall not be hazardous due to use or storage of materials, processes, products or wastes.

2. Testing facilities which are fully enclosed in a laboratory setting may operate if consistent with local zoning regulations and do not involve any other prohibited activities, including but not limited to, cultivation, processing, packaging, or sales. Temporary storage within a permitted testing facility is allowed.

B. It is unlawful for any person conducting, operating, owning, or in control of any business or premises to sell cannabis or cannabis products, whether medical (medicinal) or adult use (recreational) within the City of Capitola unless such person holds both:

1. A valid Retail Cannabis License, as outlined in 5.36.030, and

2. A conditional use permit for a retail cannabis establishment, in compliance with 17.24.020.D.1.b.

C. Except as expressly authorized herein, all commercial cannabis activity is prohibited in all areas of the City.

9.61.050 Prohibited activities declared a public nuisance.

Any use or condition caused or permitted to exist in violation of any of the provisions of this chapter shall be and is hereby declared a public nuisance and may be abated by the City or subject to any available legal remedies, including but not limited to civil injunctions.

9.61.060 Penalties for violation.

A. Any person violating any of the provisions of this chapter shall be guilty of a misdemeanor and subject to a penalty as established by law or in the City's bail schedule. Violators shall be subject to any other enforcement remedies available to the City under any applicable state or federal statute or pursuant to any other lawful power the City may possess.

B. Each day a violation is allowed to continue and every violation of the chapter shall constitute a separate violation and shall be subject to all remedies.

C. In the event any civil suit or action is brought by the City to enforce the provisions of this chapter, the prevailing party shall be entitled to recover the amount of its reasonable costs incurred in the action or proceeding, including, but not limited to, attorney's fees.

9.61.070 Severability.

If any part or subsection of this chapter is for any reason held to be invalid, unlawful, or unconstitutional, such invalidity, unlawfulness, or unconstitutionality shall not affect the validity, lawfulness, or constitutionality of any other part of this chapter.

Section 2. Effective Dates. This ordinance shall be in full force and effect thirty (30) days from the date of its adoption by the City Council.

This ordinance was introduced on the 11th day of April, 2019, and was passed and adopted by the City Council of the City of Capitola on the 25th day of April, 2019, by the following vote:

SUBJECT: Consider Options for Banning Flavored Tobacco / Vaping Products

RECOMMENDED ACTION: Accept report and provide direction.

<u>BACKGROUND</u>: During its March 28, 2019, meeting, City Council directed staff to research options to ban flavored e-cigarette, or vaping, products in Capitola and explore additional tobacco laws to prevent youth exposure to tobacco.

<u>DISCUSSION:</u> Chapter 8.38 of the Capitola Municipal Code codifies specific requirements and restrictions for businesses that sell tobacco and tobacco products (tobacco retailers) to protect public health, safety, and welfare. These include smoking prohibitions in certain areas, and to guarantee the right of non-smokers to breathe smoke-free air, and to make the public aware of the hazards of secondhand smoke, and to regulate the sale of tobacco and tobacco products only to those individuals with a minimum age of 21 per State law as of June 9, 2016 (with an exception for military personnel).

California Health Safety Code 104495 (a) (8) (A) defines a "tobacco product" as:

- 1. Any product containing, made, or derived from tobacco or nicotine that is intended for human consumption, whether smoked, heated, chewed, absorbed, dissolved, inhaled, snorted, sniffed, or ingested by any other means, including but not limited to cigarettes, cigars, little cigars, chewing tobacco, pipe tobacco, snuff; and
- 2. Any electronic smoking device.
- 3. Notwithstanding any provision of subsections (1) and (2) to the contrary, "tobacco product" includes any component, part, or accessory intended or reasonably expected to be used with a tobacco product, whether or not sold separately. "Tobacco product" does not include drugs, devices, or combination products authorized for sale by the United States Food and Drug Administration.

According to the Department of Tax and Fee Administration, the City of Capitola currently has 19 tobacco retailers (Attachment 1) of which nine currently sell flavored tobacco only, three sell flavored tobacco and flavored vape liquids, two sell flavored vape liquids only, and two do not sell flavored tobacco or flavored vape liquid.

Safety Concerns: The tobacco product landscape continues to evolve to include a variety of tobacco products, most notably electronic products known as e-cigarettes. E-cigarettes are

designed to deliver nicotine, flavorings, and other additives to the user via an inhaled aerosol. According to a 2016 study conducted by the Office of the Surgeon General, e-cigarettes entered the marketplace around 2007 and since 2014 have been the most commonly used tobacco product among U.S. youth. In 2018, more than 3.6 million U.S. youth, including 1 in 5 high school youth and 1 in 20 middle schoolers currently use e-cigarettes.

E-cigarette aerosol is not harmless, as most of the liquid vaping products sold to the public contain nicotine, which is the addictive drug in tobacco products. Nicotine exposure during adolescence can harm the developing brain, which continues to develop until age 25, subsequently impacting learning, memory, and attention. The aerosol exhaled into the air is believed to emit harmful substances including heavy metals, volatile organic compounds, and ultrafine particles that can be inhaled into the lungs.

Many e-cigarettes are marketed and sold in kid-friendly flavors, such as bubble gum, cotton candy, and chocolate peanut butter making the product more appealing to young people. E-cigarettes can also be used to deliver other drugs, including cannabis. In 2016, the Surgeon General found that one-third of middle and high school students who used e-cigarettes had used cannabis in e-cigarettes. See Attachment 2 for additional Santa Cruz County statistics.

In 2009, the United States Food and Drug Administration (FDA) banned cigarettes with characterizing flavors other than menthol (e.g., cherry, chocolate).

Currently, the FDA does not ban flavors from other tobacco products, although according to the FDA, research suggests flavors may also make these products more enticing to youth and young adults. Data from FDA's Population Assessment of Tobacco and Health found that nearly 80 percent of youth ages 12-17 and nearly 75 percent of young adults ages 18-25 who were current tobacco users in 2014 reported that the first tobacco product they ever used was flavored.

Consistent and frequent opposition against flavored tobacco bans include the following anecdotal arguments:

- Flavored tobacco users will simply order online or visit neighboring communities that haven't prohibited the sale of flavored tobacco and tobacco products.
- Prohibiting the sale of flavored tobacco will drastically reduce retailer profits and may put them out of business. The ban unfairly punishes local business owners who are often community members.
- Adults like flavored tobacco and flavor bans unfairly punish law-abiding adults.
- There are already laws in place that prevent youth from having access to tobacco products, such as the statewide law that increased the minimum sales age to 21 and local laws that prohibit tobacco sales near schools.
- Flavored e-cigarettes help people quit smoking traditional cigarettes. Restricting the sale of flavored tobacco will make it harder for individuals to quit smoking.

Despite these arguments, a number of northern California communities have taken action to ban flavored tobacco products, including the cities of San Francisco, Santa Cruz, Oakland, and El Cerrito.

Generally, those bans cover most types of flavored tobacco and include flavored cartridges for e-cigarettes, menthol cigarettes, and other forms of flavored tobacco products. A few cities have

provided an exemption for those stores that are "adult-only tobacco stores" and prohibit people under the age of 21.

While some communities have focused on only banning flavored vaping products, most northern California cities are considering more comprehensive bans on flavored tobacco products.

Current Regulations on the Sale of Tobacco Products

Sections 8.38.120 and 8.38.130 of the Capitola Municipal Code regulate the sale of tobacco products based upon the following restrictions (abbreviated):

- Seller must request I.D.
- Business not allowed to sell tobacco within 1000 feet from school or public library.
- Business shall visibly post Penal Code Section 308 (c) at the entrance of the business.
- Business shall visibly post signs at the point of purchase which comply with Business and Professions Code 22952.
- Business shall visibly post signs at each entrance stating a warning that buying tobacco for underaged persons is against the law and will result in a fine.

Options:

- 1. Direct staff to pro-actively monitor all retail tobacco establishments and enforce violations of Title 8, Chapter 8.38 of the Capitola Municipal Code.
- 2. Direct staff to prepare a new ordinance banning the sale of all flavored tobacco and flavored tobacco products in the City of Capitola.
- 3. Direct staff to prepare a new ordinance banning flavored vaping products.

If Council directs staff to proceed with Options 2 or 3, staff recommends the Council also direct staff to implement a local Tobacco Retail License program prohibiting any person from conducting business in the City of Capitola as a tobacco retailer without obtaining and maintaining a valid tobacco retail license (TRL). This will also require adopting a new ordinance amending the CMC.

Staff recommends the City consider establishing a TRL if Council adopts City-specific restrictions on types of tobacco products that can be sold. The TRL would then be used as a tool to help educate retailers regarding Capitola-specific rules and ensure compliance.

In addition to the proposed options listed above, several changes should be made to current code to reflect updated definitions and changes to state law. For example, on June 19, 2016, California increased the minimum age to purchase tobacco from 18 to 21, and language in Chapter 18.38.130 had not been updated to reflect new state law. Additionally, changing the language in the ordinance from "minor" to "youth" in several places is proposed.

63% of stores sell flavored non-cigarette products, which often have kid-appealing flavors such as grape, watermelon and gummy bear.

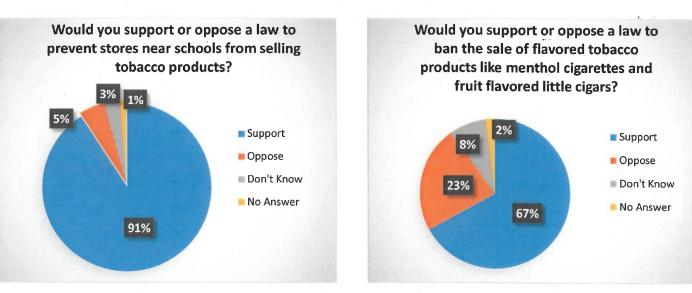
84% of stores sell menthol cigarettes.

SUBJECT: Consider a Resolution Allocating the 2019/20 Road Maintenance and Rehabilitation Account Funds

<u>RECOMMENDED ACTION</u>: Adopt the proposed resolution allocating the 2019/20 Road Maintenance and Rehabilitation Account (RMRA) funds and re-allocation of the 2018/19 RMRA funds to the Park Avenue Sidewalk Project.

<u>BACKGROUND</u>: Senate Bill 1, known as SB 1 or the Road Maintenance and Rehabilitation Account (RMRA), was signed into law in April 2017 to address the state's basic road maintenance and critical safety needs. In fiscal year 2019/2020 Capitola will receive approximately \$175,000 from RMRA.

SB 1 requires that the City adopt a resolution prior to May 1 each year indicating how the City's RMRA allocation will be used for the following fiscal year.

<u>DISCUSSION</u>: Last year the Council designated the SB 1 funds for both 2018/19 and 2019/20 to the pavement rehabilitation project on 42nd Avenue, Diamond Avenue, and Ruby Court. It was anticipated this allocation, in addition to an allocation of Measure D funds and a General Fund contribution, would be sufficient to construct the project in 2019/20. Unfortunately, the estimated cost of the project has increased significantly above the level of available funding. The current estimate is \$1.3 million and the maximum allocation from both SB 1 and Measure D funds is \$645,000.

The Park Avenue Sidewalk project has also seen a significant increase in construction costs since it was first proposed in 2012, from \$450,000 to \$985,000. In addition to the inflationary costs of construction, these increases are due to the necessary inclusion of a retaining wall at 600 Park Avenue, the addition of flashing lights at the crosswalk at Cabrillo Street, and the replacement of a failed storm drain pipe near Wesley Street.

While both projects are ready to bid, there is insufficient funding to complete either project with the current allocation of funds. Adding \$200,000 in Transportation Development Act funds from the Regional Transportation Commission and allocating all the available SB 1 and Measure D funding to the Park Avenue Sidewalk project, which is the older project, will allow it to move forward immediately. The spreadsheet in Attachment 1 details the proposed allocations.

In order to meet the State's requirements for allocation of SB 1 funds, the attached resolution

must be adopted before May 1. This resolution re-allocates the 2018/19 funds to the Park Avenue Sidewalk Project and allocates the 2019/20 funds to the same project.

FISCAL IMPACT: This allocation of the RMRA funds will be reflected in the budget and Capital Improvement Program documents, which will be presented to the Council in May.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CAPITOLA ADOPTING A LIST OF PROJECTS FOR FISCAL YEAR 2019/20 FUNDED BY SB 1: THE ROAD REPAIR AND ACCOUNTABILITY ACT OF 2017

WHEREAS, Senate Bill 1 (SB 1), the Road Repair and Accountability Act of 2017 (Chapter 5, Statutes of 2017) was passed by the Legislature and signed into law by the Governor in April 2017 to address the significant multi-modal transportation funding shortfalls statewide; and

WHEREAS, SB 1 includes accountability and transparency provisions that will ensure the residents of our City are aware of the projects proposed for funding in our community and which projects have been completed each fiscal year; and

WHEREAS, the City must adopt by resolution a list of projects proposed to receive fiscal year funding from the Road Maintenance and Rehabilitation Account (RMRA), created by SB 1, which must include a description and the location of each proposed project, a proposed schedule for the project's completion, and the estimated useful life of the improvement; and

WHEREAS, the City will receive an estimated \$174,000 in RMRA funding in Fiscal Year 2019-20 from SB 1; and

WHEREAS, this is the third year in which the City is receiving SB 1 funding and will enable the City to continue essential road maintenance and rehabilitation projects, safety improvements, repairing and replacing aging bridges, and increasing access and mobility options for the traveling public that would not have otherwise been possible without SB 1; and

WHEREAS, the City has undergone a public process to ensure public input into our community's transportation priorities/the project list; and

WHEREAS, the City completed an update to the pavement management program in 2017 to develop the SB 1 project list to ensure revenues are being used on the most high-priority and cost-effective projects that also meet the City's priorities for transportation investment; and

WHEREAS, the funding from SB 1 will help the City implement a complete street design, including construction of more than 1,000 feet of sidewalk along Park Avenue this year and various road improvements into the future; and

WHEREAS, the SB 1 project list and overall investment in our local streets and roads infrastructure with a focus on basic maintenance and safety, investing in complete streets infrastructure, and using cutting-edge technology, materials and practices, will provide a dedicated source of funding for roadway projects.

NOW, THEREFORE IT IS HEREBY RESOLVED, ORDERED AND FOUND by the City Council of the City of Capitola, State of California, as follows:

SB 1 Project List 2019/20 April 25, 2019

- 1. The foregoing recitals are true and correct.
- 2. The following list of proposed projects will be funded in-part or solely with fiscal year 2018-19 and fiscal year 2019-20 Road Maintenance and Rehabilitation Account revenues:

Park Avenue Sidewalk Project – new sidewalks to provide complete street facilities along Park Avenue from McCormick Avenue to Cabrillo Street. Estimated useful life is 50 years, project will be completed in 2019-20

3. The following previously proposed and adopted projects in year 2018-19 will be deferred until a future year.

The pavement rehabilitation project on 42nd Avenue from Jade Street to Capitola Road, Diamond Avenue from 42nd Avenue to 45th Avenue, and Ruby Court.

SUBJECT: Consider Fee Schedule for Fiscal Year 2019-20

<u>RECOMMENDED ACTION</u>: Conduct the noticed public hearing on the proposed City Fee Schedule for Fiscal Year 2019/2020 and adopt the proposed Resolution repealing Resolution No. 4132 and adopting the new fee schedule.

<u>BACKGROUND</u>: Part of the annual budget process is a review of the City's Fee Schedule. The current fee schedule is based on the comprehensive fee study adopted on November 24, 2015. The consultant recommended the City review the fee schedule on a yearly basis and implement a Consumer Price Index (CPI) adjustment, which accounts for most of the increases in fees.

State law requires the City conduct a public hearing where testimony can be taken before any fees are added or existing fees are altered.

<u>DISCUSSION</u>: Staff is recommending a 3.87 percent CPI adjustment, which is the calendar year 2018 rate for the Bay Area, to most fees listed on the schedule. In addition, staff is proposing several new fees outlined below.

Miscellaneous Fees: The "Annual Cannabis License Fee" is the one new proposed Miscellaneous fee. The fee is intended to recover costs associated with the annual licensing and inspections of retail cannabis operators. The new fee is proposed to be set at \$2,550 in FY 2019-20 and covers Planning Division review as well as two annual inspections by the Police Department. Staff anticipates a total of 1½ hours of Planning Division time (\$212.04), 3½ hours of police sergeant time (\$679.88), and 5½ hours of police officer time (\$1,658.08).

All other miscellaneous fees include the CPI adjustment of 3.87 percent with the following exceptions: Notice of Intent to Circulate Initiative Petition and Notary Service Fees are set by the state at a maximum of \$200 and \$15 respectively, and the 15-cent-a-page charge for Municipal Code copies, which is the cost to the City from the codifying service.

Parks and Recreation Fees: Two new fees are proposed as part of an afterschool pilot program, the "Teen Club" and "K to 6th" fees. The weekly and daily fees were developed by surveying similar programs offered in Santa Cruz County and setting Capitola's fee around the midpoint of fees charged by other programs. This approach will provide adequate resources to develop an enrichment-focused afterschool program while still providing a public service.

All other recreation fees reflect a 3.87 percent CPI adjustment, with the exception of the Junior Guards regionals fee, which has decreased from \$235 to \$93 since bus service is no longer being provided.

Police Department Fees: Police department fees reflect a 3.87 percent inflationary adjustment.

Animal Service Fees: Animal service fees are set by Santa Cruz County and this Resolution adopts the fee schedule the County has approved for 2019-20.

Building Fees: Three new fees are proposed: "Building Reinspection Fee" of \$125, "Resubmission Plan Check Fee" of \$106.77 an hour, and "Building Permit Extension Fee" of \$176. All three fees are for time and services beyond what is included with a Building Permit Fee and were established on a cost recovery basis. The Building Reinspection Fee estimates ¹/₄ of one hour of Development Services Technician time (\$26.18) and 1 hour of Building Inspector I time (\$99.76). The Resubmission Plan Check Fee is based on the fully loaded salary and benefit cost of a Building Inspector II, which is \$106.77 per hour. Finally, the Building Permit Extension Fee anticipates one hour of Building Official time (\$124.13) and a ¹/₂ hour of Development Services Technician time (\$52.37).

All other building fees reflect a 3.87 percent inflationary adjustment.

Planning Fees: Planning fees reflect a 3.87 percent inflationary adjustment.

Public Work Fees: Public Works fees reflect a 3.87 percent inflationary adjustment.

Historical Museum Fees: The Historical Museum fees reflect a 3.87 percent inflationary adjustment.

<u>FISCAL IMPACT</u>: The CPI adjustment helps offset increased costs to provide services to the community. The Fiscal Year 2019/20 Budget will incorporate the higher fees and the Fee Schedule goes into effect July 1, 2019.

RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CAPITOLA REPEALING RESOLUTION NO. 4132 AND ADOPTING THE CITY'S FEE SCHEDULE FOR FISCAL YEAR 2019-2020

WHEREAS, the Government Code of the State of California, Section 66018 requires local agencies to notice and hold at least one open and public meeting prior to levying a new fee or increasing an existing fee; and

WHEREAS, the City Council of the City of Capitola has held a duly noticed public hearing on April 25, 2019, to consider increases to existing fees charged for various City services; and

WHEREAS, this fee schedule sets forth the City's cost recovery fee programs, which includes minimum deposits against which staff costs, adjusted for overhead, are assessed; and

WHEREAS, the City Council adopted Resolution No. 3285 on May 22, 2003, stating that all flat fees, with the exception of those established by law, shall be adjusted annually by the Consumer Price Index (CPI) for the San Francisco, Oakland, San Jose area, which was 3.87 percent for 2018; and

WHEREAS, the City of Capitola will analyze the fee schedule on a yearly basis to ensure hour estimates and staff costs are reasonable; and

WHEREAS, the fee schedule has been updated as described in Exhibit A; and

WHEREAS, the City of Capitola has made available to the public the required data pursuant to Government Code Section 66018 for at least ten days prior to adoption of a revised fee schedule.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Capitola does hereby:

- Repeal Resolution No. 4132; and
- Adopt the City of Capitola Fee Schedule pursuant to the changes in Exhibit A attached hereto to become effective on July 1, 2019; and
- Adopt the Animal Services Fees identified in Exhibit B attached hereto to become effective on July 1, 2019.

SUBJECT: Consider Bail Schedule for Fiscal Year 2019/20

<u>RECOMMENDED ACTION</u>: Adopt the proposed Resolution repealing Resolution No. 4065 and adopting the new bail schedule.

<u>BACKGROUND</u>: A regular update of the City's Bail Schedule, the official list of fines for local violations, is necessary to maintain a schedule that is consistent with the Capitola Municipal Code. New ordinances must be reviewed and incorporated to ensure that the Bail Schedule reflects the City's current code. This schedule must also be kept up to date for the Capitola Police Department to accurately process citations of code violations and for the use of the Santa Cruz County Court database.

<u>DISCUSSION</u>: Below is a list of Municipal Code sections that require changes to the Bail Schedule. The changes are proposed because the code section was adopted since the last bail schedule update, the bail amounts were previously missing from the bail schedule, or the code section was revised.

The full Bail Schedule, with previously adopted bail amounts and proposed changes, is also attached to this report as an exhibit to the resolution.

SUBJECT: Second Reading of an Uncodified Ordinance Regarding Removal of Optional CalPERS Membership for Future Council Members

RECOMMENDED ACTION: Adopt ordinance.

<u>BACKGROUND/DISCUSSION</u>: At the October 11, 2018, City Council meeting, the City Council directed staff to initiate the process to remove the optional CalPERS (California Public Employees Retirement System) membership for future Council members. The attached ordinance implements this prior Council direction.

Currently two City Council members are part of CalPERS; this would not impact the current Council, only future Councils. City Council members not part of CalPERS are covered by PARS (Public Agency Retirement System).

At the March 28, 2019, City Council meeting, the Council approved the first reading of the ordinance and a resolution of intent.

<u>FISCAL IMPACT</u>: There is no fiscal impact in Fiscal Years 2018/2019 or 2019/2020. The additional cost to the City of a Council Member participating in CalPERS retirement rather than PARS is approximately \$325 annually per Council Member.

SECTION 2. The City Manager of the City of Capitola is hereby authorized, empowered, and directed to execute said amendment for and on behalf of said Agency.

SECTION 3. PUBLICATION. This ordinance shall be published and posted as required by law.

SECTION 4. **EFFECTIVE DATE**. This Ordinance shall be in full force and effect 30 days after the date of final passage.

California Public Employees' Retirement System

AMENDMENT TO CONTRACT

Between the Board of Administration California Public Employees' Retirement System and the City Council City of Capitola

The Board of Administration, California Public Employees' Retirement System, hereinafter referred to as Board, and the governing body of the above public agency, hereinafter referred to as Public Agency, having entered into a contract effective May 15, 1970, and witnessed January 12, 1970, and as amended effective January 1, 1982, September 1, 1983, April 1, 1992, May 16, 1999, June 11, 2000, April 29, 2001 and December 30, 2007 which provides for participation of Public Agency in said System, Board and Public Agency hereby agree as follows:

- A. Paragraphs 1 through 14 are hereby stricken from said contract as executed effective December 30, 2007, and hereby replaced by the following paragraphs numbered 1 through 17 inclusive:
 - 1. All words and terms used herein which are defined in the Public Employees' Retirement Law shall have the meaning as defined therein unless otherwise specifically provided. "Normal retirement age" shall mean age 55 for classic local miscellaneous members, age 62 for new miscellaneous members, age 50 for classic local safety members and age 57 for new safety members.
 - 2. Public Agency shall participate in the Public Employees' Retirement System from and after May 15, 1970 making its employees as hereinafter provided, members of said System subject to all provisions of the Public Employees' Retirement Law except such as apply only on election of a contracting agency and are not provided for herein and to all amendments to said Law hereafter enacted except those, which by express provisions thereof, apply only on the election of a contracting agency.

- 3. Public Agency agrees to indemnify, defend and hold harmless the California Public Employees' Retirement System (CalPERS) and its trustees, agents and employees, the CalPERS Board of Administration, and the California Public Employees' Retirement Fund from any claims, demands, actions, losses, liabilities, damages, judgments, expenses and costs, including but not limited to interest, penalties and attorney fees that may arise as a result of any of the following:
 - (a) Public Agency's election to provide retirement benefits, provisions or formulas under this Contract that are different than the retirement benefits, provisions or formulas provided under the Public Agency's prior non-CalPERS retirement program.
 - (b) Any dispute, disagreement, claim, or proceeding (including without limitation arbitration, administrative hearing, or litigation) between Public Agency and its employees (or their representatives) which relates to Public Agency's election to amend this Contract to provide retirement benefits, provisions or formulas that are different than such employees' existing retirement benefits, provisions or formulas.
 - (c) Public Agency's agreement with a third party other than CalPERS to provide retirement benefits, provisions, or formulas that are different than the retirement benefits, provisions or formulas provided under this Contract and provided for under the California Public Employees' Retirement Law.
- 4. Employees of Public Agency in the following classes shall become members of said Retirement System except such in each such class as are excluded by law or this agreement:
 - a. Local Fire Fighters (herein referred to as local safety members);
 - b. Local Police Officers (herein referred to as local safety members);
 - c. Employees other than local safety members (herein referred to as local miscellaneous members).
- 5. In addition to the classes of employees excluded from membership by said Retirement Law, the following classes of employees shall not become members of said Retirement System:

a. COUNCIL MEMBERS PROSPECTIVELY ON AND AFTER THE EFFECTIVE DATE OF THIS AMENDMENT TO CONTRACT.

6. Removal of the exclusion of "ALL HOURLY RATED OR HOURLY BASIS EMPLOYEES" pursuant to Section 20503, is declarative of agency's previous interpretation and does not mandate any new classes of employees into membership.

- 7. The percentage of final compensation to be provided for each year of credited prior and current service for classic local miscellaneous members in employment before and not on or after December 30, 2007 shall be determined in accordance with Section 21354 of said Retirement Law, subject to the reduction provided therein for service prior to December 31, 1981, termination of Social Security, for members whose service has been included in Federal Social Security (2% at age 55 Full and Modified).
- 8. The percentage of final compensation to be provided for each year of credited prior and current service for classic local miscellaneous members in employment on or after December 30, 2007 shall be determined in accordance with Section 21354.4 of said Retirement Law, subject to the reduction provided therein for service prior to December 31, 1981, termination of Social Security, for members whose service has been included in Federal Social Security (2.5% at age 55 Full and Modified).
- 9. The percentage of final compensation to be provided for each year of credited prior and current service as a new local miscellaneous member shall be determined in accordance with Section 7522.20 of said Retirement Law (2% at age 62 Full).
- 10. The percentage of final compensation to be provided for each year of credited prior and current service as a classic local safety member shall be determined in accordance with Section 21362.2 of said Retirement Law (3% at age 50 Full).
- 11. The percentage of final compensation to be provided for each year of credited prior and current service as a new local safety member shall be determined in accordance with Section 7522.25(d) of said Retirement Law (2.7% at age 57 Full).
- 12. Public Agency elected and elects to be subject to the following optional provisions:
 - a. Section 21572 (Increased Level of 1959 Survivor Benefits).
 - b. Section 20938 (Limit Prior Service to Members Employed on Contract Date) for elected officials employed on April 1, 1992.
 - c. Section 20965 (Credit for Unused Sick Leave).
 - d. Section 20503 (To Remove the Exclusions of "All Hourly Rated or Hourly Basis Employees" and recreation Department Employees, Prospectively from June 11, 2000).
 - e. Section 20042 (One-Year Final Compensation) for classic members only.
 - f. Section 21024 (Military Service Credit as Public Service).

Section 20516 (Employees Sharing Cost of Additional Benefits):

Section 21354 (2% @ 55 Full formula) and Section 20965 (Credit for Unused Sick Leave), effective 5/16/1999, 4.770%, Section 20042 (One-Year Final Compensation) effective 4/29/2001, 1.446%, and Section 21354.4 (2.5% @ 55 Full formula) effective 12/30/2007, 2.043% for classic local miscellaneous members.

The employee cost sharing contributions are not to exceed 8.259%. The maximum employee cost sharing contribution is the normal cost plus the increase in the accrued liability due to the benefit improvement amortized over 20 years. In no event shall the employee cost sharing contribution attributable to the unfunded liability remain in effect beyond June 30, 2019. Thereafter, in any given contribution year, the maximum employee cost sharing contribution cannot exceed 3.105% of payroll.

- 13. Public Agency, in accordance with Government Code Section 20790, ceased to be an "employer" for purposes of Section 20834 effective on January 1, 1982. Accumulated contributions of Public Agency shall be fixed and determined as provided in Government Code Section 20834, and accumulated contributions thereafter shall be held by the Board as provided in Government Code Section 20834.
- 14. Public Agency shall contribute to said Retirement System the contributions determined by actuarial valuations of prior and future service liability with respect to local miscellaneous members and local safety members of said Retirement System.
- 15. Public Agency shall also contribute to said Retirement System as follows:
 - a. A reasonable amount, as fixed by the Board, payable in one installment within 60 days of date of contract to cover the costs of administering said System as it affects the employees of Public Agency, not including the costs of special valuations or of the periodic investigation and valuations required by law.
 - b. A reasonable amount, as fixed by the Board, payable in one installment as the occasions arise, to cover the costs of special valuations on account of employees of Public Agency, and costs of the periodic investigation and valuations required by law.
- 16. Contributions required of Public Agency and its employees shall be subject to adjustment by Board on account of amendments to the Public Employees' Retirement Law, and on account of the experience under the Retirement System as determined by the periodic investigation and valuation required by said Retirement Law.

17. Contributions required of Public Agency and its employees shall be paid by Public Agency to the Retirement System within fifteen days after the end of the period to which said contributions refer or as may be prescribed by Board regulation. If more or less than the correct amount of contributions is paid for any period, proper adjustment shall be made in connection with subsequent remittances. Adjustments on account of errors in contributions required of any employee may be made by direct payments between the employee and the Board.
