





ART & CULTURAL COMMISSION Program Reports

SUBJECT: Report out for budgeted Art & Cultural programs.

Recommended Action: Receive report from committee chairs or staff for budgeted programs.

BACKGROUND

The Capitola Art & Cultural Commission is an advisory body whose responsibility is to advise the City Council as to the allocation of public art funds and encouragement of existing and new programs in the arts for the enjoyment of the residents.

The Art & Cultural Commission participates in annual goal setting from which programs in the arts are planned for production in the budget year. The 2023/24 budget has planned twelve (12) Twilight Concerts, four (4) Art at the Beach, two (2) Movies at the Beach and Plein Air.

Committees shall consist of no fewer than two (2) and no more than three (3) commissioners. If a vacancy occurs, the commission can choose to appoint a commissioner to the vacancy. The program committees are as follows:

- 1) Twilight Concerts: Commissioner Wallace, Commissioner Beltramo and Commissioner Cahalen sit on the committee.
- 2) Art at the Beach: Chair Johnson, Vice Chair Hill and Commissioner Cahalen sit on the committee.
- 3) Movies at the Beach: Commissioner Cahalen and Commissioner Christiansen sit on the committee.
- 4) Plein Air: Vice Chair Hill and Commissioner Major sit on the committee.

DISCUSSION

The production of programs requires long term planning and collaboration with partners, volunteers, commissioners, and Staff. Regular reports from committee chairs are provided to enhance communication and planning as well as keeping the entire commission up to date on the progress of program activities. Additionally, committees shall report to the commission no less than a quarterly basis. Program Reports are intended to only report on the progress of a budgeted event and committee activity. Any action requiring the entire commission to make a decision outside of committee activity will be added to the agenda under General Business.

SUBJECT: Capitola Wharf Enhancement Project – Mosaic Art

Recommended Action: Review mosaic art design for Capitola Wharf Enhancement Project

BACKGROUND

As part of the Wharf Resiliency and Public Access Improvement Project, community volunteers have come together to raise private donations for the Capitola Wharf Enhancement Project (CWEP). This initiative aims to introduce new and upgraded amenities to Capitola Wharf, enhancing its usability for the community.

The CWEP incorporates a significant art component to elevate the cultural and aesthetic appeal of the project. While conceptual plans for the art components, including the gate and entry design, were approved by the commission on December 12, 2023, the final gate design and location of donor features were approved during a special meeting of the Planning Commission on March 27, 2024, but not the art itself.

Subsequently, the City has engaged Kathleen Crocetti to complete the mosaic art feature on the entry gate and the donor feature. Feedback has been solicited through three public meetings to refine the project scope, informing the final designs. Although not obligatory, the artist has requested that the Art and Cultural Commission review the final artwork design, given their regular oversight of public art in the City.

DISCUSSION




Figure 1. Wharf Entry Gate

The approved gate and wall design maintain the existing archway's aesthetics, with the addition of tiled mosaic panels created by local artist Kathleen Crocetti. These panels will be recessed and framed by fluted stone, integrating seamlessly into the entryway's structure (Figure 1).




Figure 2. Donor Panel Layout

Additionally, the wharf enhancements include the installation of seven recognition panels on the railing, listing the names of individuals and entities contributing to the CWEP (Figures 2 and 3).

While placeholder examples of artwork are provided, the final art will adorn the entry gate, with the donor panels depicting an underwater scene. Visuals of this art will be presented during the meeting, given the timing of the Planning Commission approval shortly before the agenda's publication.

FISCAL IMPACT

Funds raised specifically for the CWEP will cover the expenses associated with these public art pieces. No public art funds will be allocated for this project.

SUBJECT: SUESD Park & Washburn Art Proposal

<u>Recommended Action</u>: Receive report from Soquel Union Elementary School District (SUESD) Staff on Park and Washburn Art Project and provide feedback on project concept.

BACKGROUND

In a meeting with City Staff and the Mayor, SUESD Staff proposed an art project partnership with the City that received a positive response from City Council. The proposal is a Tile Art Project for the retaining wall located at Park Avenue and Washburn Avenue intersection. The project would focus on the larger portion of the wall, which is City owned. A small portion of the retaining wall is located on private property.

SUESD students, as part of their standard curriculum, learn about the local community and environment. The students will create tiles that represent important elements of our community's land, sea life and health. The project will use Expanded Learning Opportunity Program (ELO-P) funds for the purchase of materials. The City will partner with the school district for the installation of the tiles.

DISCUSSION

SUESD Staff will present the concept and incorporated feedback from the March 2024 Art & Cultural Commission meeting for commission feedback. The Commission is to provide feedback on the final concept.

FISCAL IMPACT

Project costs for this Public Art will draw from the Public Art Fund for the installation of the tiles. Staff estimate for the installation is \$10,000 and this expenditure will be incorporated into the budget. The Public Art Fund currently has a balance of \$159,955 and the commission had budgeted \$75,500 to current projects. The FY 23/24 budget has \$69,100 remaining.

Background

The original Proposal was presented to the City of Capitola in August 2023, and represented the idea spurred by a well known educator in the Soquel Union Elementary School District who, as member of the community, noticed that the cement wall on Washburn was an amazing open canvas for a potential joint art project, which could possibly curb graffiti.

Community Tile Project Proposal (draft) August 2, 2023

OVERVIEW

The City of Capitola is a wonderful place to live and learn. From land to sea, our community thrives- rich in natural and human resources. It is in this vein, that we propose the following community beautification partnership to be located at Park Avenue and Washburn in Capitola on the existing concrete retaining wall.

GOALS

- While students in the Soquel Union Elementary School District learn about our local community and environment, they will create tiles that represent important elements of our community's land and sea life, and health. (There would be approximately 1600 3"x3" tiles in all.)
- The city and schools will partner with the Soquel Union Elementary Schools to create an artful student-created wall space for the locals and guests to enjoy.

SPECIFICATIONS

It is our proposal for the City of Capitola to join us in the beautification project in any way possible, beginning with approving the proposal outlined in the milestones below.

MILESTONES

August-September 2023

Approve project proposal.

October-December 2023

Students and staff engage in standards-based science and social science lessons to generate new social and environmental knowledge relevant to our community. January-May 2024

Through our district's expanded learning opportunity program (ELOP) grant, bring in students from Transitional Kindergarten through Grade 8 to create artful tiles, and prepare them for application.

June-July 2024

Host a ground-breaking ceremony before the tile application process and partner with the city for the labor of such an application.

Art Proposal: Specifications

Specifications of the project include the installation of student produced high quality tile art organized and design formatted by Roy Segura and Soquel Union Elementary School District staff support.

SPECIFICATIONS

Each student and involved community member will create and paint a 6" X 6"ceramic tile illustration with a theme related to the city of Capitola.

Background:

The assistant superintendent was contacted by a teacher about creating a community art project to cover an existing wall that has been continually vandalized. Ceramic tiles were the media of choice as they are long lasting, colorful as well as resistant to graffiti. The proposal was taken to the city for approval. Currently, the school district will use ELOP funding for the art materials needed. The city will install the tiles following the strategies provided by the instructors involved. The project is currently in review.

Materials:

Each student will have one tile of 6" x 6" square dimension. The goal is to have as many students in the district create one tile. An estimate of the tiles needed is open at this point, however, a suggested purchase is to begin with 500 tiles. The goal would be to involve all students of the four schools. (1500) These are to be bisque fired tiles when purchased. It is suggested to buy a kit of UNDER GLAZES for each school involved. The kit should include primary, secondary and values. Each student will have a medium brush and detail brush.

These materials will all be appropriate for glazing.

Arts Proposal: Themes

The themes associated with this beautification project reflect the wonders of the great City of Capitola, including biomes, history, etc. that students have learned about in schools and as active members of the

community.

THEMES

The wall provided is located in the city of Capitola. Therefore, the theme focuses on the city of Capitola as they are co funding the project. The theme will include the unique human and natural resources of the area.

As this is an educational as well as a beautification project, the images will correspond to educational standards in different disciplines: science, math, art, history, physical education, etc. State standards will be included within the acknowledgements of the images. The images will also include celebrations/ festivals of Capitola.

Suggested ideas: (discipline related to grade level)

Biomes: temperate forest, coastal cliffs, dry chaparral Fauna unique to Capitola: grassland, riparian, shore and ocean, avian (mammals, reptiles, fish, crustaceans, birds, mollusks, etc.) Vegetation found in Capitola: trees, plants, flowers

History: Buildings and people, native Americans Festivals: skateboarding, Begonia (sand castles, fishing derby, horse shoe contest, parade) Classic Cars, Art and Wine, Wharf to Wharf

Activities: water sports, biking, singing, fishing, etc.

Theme images should be explored by instructors and students. School texts, internet, periodicals etc should be used as resources. Images can be cropped to required scale and simplified for six inch square formats.

Presentation of Lessons:

Teachers present the project to students during expanded learning opportunity class time. Focus on celebrating the Capitola community, beautification of the town, self-creative growth, permanences of tile work as a presentation of themselves to the public and family. (Mural and tile work as art form.)

Art Proposal: Install

The installation of the tiles is expected to occur in the summer of 2024. The installation will be overseen by Roy Segura, though the installer will be funded by the City of Capitola.


INSTALLATION FOR SUMMER 2024

All tile work will be gathered and arranged based on the themes, and amounts. The work needs to be analyzed to calculate aesthetic arrangement.

An illustration will be rendered of the desired groupings and positioning. (Number tiles using a sharpie. A cross grid pattern can be helpful.)

Collect tile in selected boxes with groupings.

Present and explain the arrangement with the installer using the position diagram and boxes of tile in coordination.



SUBJECT: Begonia Festival Commemorative Public Art Project

<u>Recommended Action</u>: Receive revised concept from selected project artist and recommend project for contract and Council presentation.

BACKGROUND

The Commission approved a committee to work on a Public Art project for the Begonia festival and choose the park next to Soquel Creek by Stockton Ave as the installation location. The Begonia Festival has offered to contribute funds to the project. Commissioner Hill is the Chair of the committee. City Council was informed about the project at the October 13, 2022 Council meeting. The committee consists of Chair Johnson, Vice Chair Hill & Commissioner Cahalen.

A Call to Artist was released on March 10, 2023 for the project and the deadline for submission passed on April 30, 2023. At the July 2023, the Commission received 3 presentations from the three (3) selected artists; Lea de Wit, Adrian Litman and Geoffrey Nelson. The committee decided to proceed with Geoffrey Nelson for further development of the concept.

DISCUSSION

The Begonia Festival Commemorative Art Project committee provided feedback to the selected artist Geoffrey Nelson who is to present the revised concept.

FISCAL IMPACT Project costs from the Public Art fund will be \$20,000 with a matching contribution from Beach Festival. The Public Art Fund currently has a balance of \$171,667 and the commission has \$55,500 committed to current projects.
