Please refer to code of Civil Procedure §1094.6 to determine how to calculate when a decision becomes "final." Please be advised that in most instances the decision become "final" upon the City Council's announcement of its decision at the completion of the public hearing. Failure to comply with this 90-day rule will preclude any person from challenging the City Council decision in court.

SUBJECT: Presentation of the Proposed 2016/2017 Fiscal Year Budget for the City of

Capitola General Fund, the Capitola Successor Agency, and an Overview of the

Capital Improvement Program

<u>RECOMMENDED ACTION:</u> Receive the Proposed Fiscal Year 2016/2017 and Planned Fiscal Year 2017/2018 Budget for the City and Successor Agency to the former Redevelopment Agency; receive an overview of the Capital Improvement Program, and provide staff direction.

<u>DISCUSSION</u>: The City of Capitola proposed Fiscal Year (FY) 2016/2017 and FY 2017/2018 Budget is a two-year financial plan for the City. The proposed Budget was prepared based on the Council's adopted budget principles, while taking into account projections of future revenue. The Budget is the City's operating plan and a primary mechanism by which the Council's goals and vision for the City are transmitted to staff for implementation.

The document is organized to present information in several ways. General Fund Revenues and Expenditures are shown to provide information about longer term patterns and overall fiscal stability, then revenues and expenditures for the City's various funds and departments are shown to provide additional detail and information about the City's programs and projects.

The balanced FY 2016/2017 proposed Budget appropriates 100% of the Measure O sales tax revenues to the ballot's stated priorities. This includes funding for over \$700,000 in Capital Improvement Program (CIP)/Street Projects and \$135,000 to fully fund reserves to policy established levels. In this final year of the Measure O/D overlap, the budget includes an evaluation of the original funding commitment, and the actual uses of Measure O.
