**Note:** Any person seeking to challenge a City Council decision made as a result of a proceeding in which, by law, a hearing is required to be given, evidence is required to be taken, and the discretion in the determination of facts is vested in the City Council, shall be required to commence that court action within ninety (90) days following the date on which the decision becomes final as provided in Code of Civil Procedure §1094.6. Please refer to code of Civil Procedure §1094.6 to determine how to calculate when a decision becomes "final." Please be advised that in most instances the decision become "final" upon the City Council's announcement of its decision at the completion of the public hearing. Failure to comply with this 90-day rule will preclude any person from challenging the City Council decision in court.

SUBJECT: PROPOSED FISCAL YEAR 2013/14 AND FISCAL YEAR 2014/15 BUDGET FOR THE

CITY AND THE SUCCESSOR AGENCY TO THE FORMER REDEVELOPMENT

AGENCY (RDA)

**RECOMMENDED ACTION:** Receive the Proposed Fiscal Year (FY) 13/14 and Planned FY 14/15 Budget for the City and Successor Agency to the former Redevelopment Agency and Provide staff direction.

**DISCUSSION:** The City of Capitola Proposed FY13/14 and FY14/15 Budget is a two year financial plan for the City. The proposed Budget was prepared based on the Council's adopted budget principles, while taking into account projections of future revenue. The Budget is the City's operating plan and a primary mechanism by which the Council's goals and vision for the City are transmitted to staff for implementation.

The document is organized to present information in several ways. General Fund revenues and expenditures are shown to provide information about longer term patterns and overall fiscal stability, then revenues and expenditures for the City's various funds and Departments are shown to provide additional detail and information about the City's programs and projects.


The balanced FY 13/14 Proposed Budget appropriates 100% of the Measure O sales tax revenues to the ballot's stated priorities. This includes funding for over \$490,000 in CIP/street projects and \$463,300 to increase reserves.

The FY 13/14 Budget does not include expenditures related to the \$1.35 million Pacific Cove pipe failure insurance settlement. During the budget hearing process, staff and the Finance Advisory Committee will present recommendations on the following alternative uses of the settlement funds:

- Prepayment of debt obligations
- · Allocations to reserve accounts; and
- Funding for Capital improvement projects

With the Measure O contribution combined with a percentage of the settlement funds, the blended reserve balances will be within 70-80% of their \$3 million target.

### Measure O Expenditures



The next Budget Study Session will be held on Thursday, May 30, 2013, at 6 PM. The agenda items will include Finance Advisory Committee recommendations and Community Based Health and Human Services Provider presentations.
