SPECIAL JOINT BUDGET STUDY SESSION OF THE CAPITOLA CITY COUNCIL AND THE SUCCESSOR AGENCY TO THE FORMER REDEVELOPMENT AGENCY

Note: Any person seeking to challenge a City Council decision made as a result of a proceeding in which, by law, a hearing is required to be given, evidence is required to be taken, and the discretion in the determination of facts is vested in the City Council, shall be required to commence that court action within ninety (90) days following the date on which the decision becomes final as provided in Code of Civil Procedure §1094.6. AGENCY (RDA)

RECOMMENDED ACTION: Receive the Proposed FY 2012/13 and FY 2013/14 Budget for the City and Successor Agency to the former Redevelopment Agency and Provide staff direction.

<u>DISCUSSION</u>: The City of Capitola Proposed FY12/13 and FY13/14 Budget is a two year financial plan for the City. The proposed Budget was prepared based on the Council's adopted budget principles, while taking into account projections of future revenue. The Budget is the City's operating plan and a primary mechanism by which the Council's goals and vision for the City are transmitted to staff for implementation.

The document is organized to present information in several ways. General Fund revenues and expenditures are shown to provide information about longer term patterns and overall fiscal stability, then revenues and expenditures for the City's various funds and Departments are shown to provide additional detail and information about the City's programs and projects.

As presented, the Proposed Budget is balanced; however it contains \$299,720 in unallocated funds for FY12/13. During a public hearing in March, the City Council directed staff to defund a number of programs in the Proposed Budget, and provide Council with an unallocated source of funds which could be assigned during the budget process.

The FY12/13 Budget exclude the items presented in the table below, along with removing \$280,000 that would be allocated to the Contingency and Emergency Reserve Funds pursuant to the Council goal of reestablishing the City's reserve funds within five years. Of the \$299,720 in unallocated funds in FY2012/13, \$265,000 will be generated from one-time revenues.

Staff recommends the City Council allocate the maximum level of funding possible to the City's reserve funds. With the current funding level in the reserve accounts, the City's ability to withstand unanticipated events (natural disasters, state take-aways, litigation, etc.) is very limited. With such

low levels of reserves the City may need to consider bridge-financing to cover operational cash shortfalls during the course of the fiscal year. Staff will present a cash flow analysis at the hearing outlining the City's cash position projections for next fiscal year. Lastly, in the citizen survey conducted this Spring, when likely voters were asked to identify their priorities for uses of new tax revenue, they indicated that ensuring the City's long-term fiscal stability and restoring reserve funding levels were very high priorities.

While it may be a high priority to the City Council to provide some funding for a CIP project in the next fiscal year, it is important to note a slurry seal project, funded in a previous year's CIP, is scheduled to go out to bid this summer, with construction scheduled for the Fall.

The next Budget Study Session will be held on Thursday, May 31, 2012, at 6 PM, where the Finance Advisory Committee will present their recommendations.
