City Hall Supplies Procurement & Recycling

#### **Public Works**

The Capitola Public Works Department is committed to proactively reducing our waste stream, recycling when possible, and using environmentally friendly products when applicable.

Eight years ago, while reviewing our purchasing of cleaning supplies, it was discovered that there where better alternatives that were less harmful to the crew, the public, and the environment. The main source of concern was the cleaning chemicals, which contained acids and other harsh chemicals. We solicited bids from several cleaning supply firms focusing on "green" chemicals, paper with recycled content, and price. We chose Cleansource (now Supplyworks) because they best fit our needs. We trained the crew on the use and benefits of the new products and completed the conversion.

We then took a look at how we handled waste in our Corporation Yard. Working with Waste Management/Greenwaste, we added additional roll off bins and built two open faced bins; one for green waste and one for garbage. We now have the ability to separate metal and green waste for recycling from our garbage. We have also added a 4-yard bin at the yard so that we can recycle cardboard and paper. We also collect old batteries and recycle them through Greenwaste. Old florescent tubes and paint are now collected and stored on site until they can be transported to the Buena Vista landfill for recycling. Old metal street signs are repurposed by sending them to a sign manufacturer where they are hydro-stripped and re-sheeted with a new reflective sign surface. To keep dog waste off our sidewalks and out of our water systems, the City supplies green dispensers with biodegradable bags throughout our town.

In our City parks and right of ways, we use an integrated management system to minimize waste. We operate on the three L's: low water, low maintenance, and lots of color. In our parks, ornamental turf has been reduced to essential playing surfaces and high value sites. Spray irrigation systems in our landscapes are continually being converted to drip irrigation systems to improve water efficiently. Drought tolerant plants, succulents, and native plants are inter-planted with colorful perennials and ornamental grasses in these landscaped areas. We use recycled wood chips in our City landscapes to beautify, save water, and eliminate hauling to a landfill. Wood chips used in conjunction with weed block fabrics have helped us to control weeds and keep the use of pesticides to a minimum.

The mechanics also participate in our recycling effort. Used oil and antifreeze are collected and stored in a shed until they are picked up for recycling. Old tires are recycled at the Buena Vista landfill.

#### City Hall

City Hall has been implementing many of the best practices recommended for preferable product purchasing and practices. Daily practices such as using copy paper and most paper products that are 50% post-consumer recycled content, remanufactured printer toner cartridges, utilizing duplex features for printing, scanning documents for storage and transmission of electronic information; and establishing a digital reading device purchasing policy to reduce the amount of paper waste from the production of paper packets.

All departments practice waste prevention and recycle wherever possible.

**Categories of Grants:** The WHALE TAIL® Grants Program funds projects that fall into any one of the following three categories: 1) Adopt-A-Beach®programs; 2) Youth programs; 3) Programs for the general public. In addition, applicants may request funding under a subcategory for projects addressing climate change and/or ocean acidification.

**Eligibility:** Applicants must be either a non-profit organization, a school, or a governmental entity. For beach operation and maintenance projects, the applicant must be a non-profit organization or local governmental agency. For proposals in the Adopt-A-Beach® category, both current and new Adopt-A-Beach® managers are eligible to apply.

**Background:** This program distributes funds from sales of the WHALE TAIL® Coastal Protection License Plate and from donations to the "Protect Our Coast and Oceans Fund" listed on the California state tax form. The WHALE TAIL® License Plate is an official "specialty" license plate issued by the California Department of Motor Vehicles. Proceeds from the sales of the plates benefit the California Coastal Commission's Adopt-A-Beach® Program, California Coastal Cleanup Day and a wide variety of coastal and marine education projects throughout the state. The "Protect Our Coast and Oceans Fund" is one of the "tax check-off" funds listed on the California state tax form, offering taxpayers the option to provide voluntary donations of any amount. Proceeds from contributions to this fund specifically benefit the WHALE TAIL® Grants Program.

#### Hello Kailash-

Sorry for not responding soon...I have been out of town. You might want to call me about gathering more information and understanding why the markets in the past did not work. The short answer is SCCFM is not interested in starting a market in Capitola or another market in the county. We have enough and adding another market down the street from Cabrillo and the Eastside FM makes no sense. Food dollars just will get split up. My growers won't go for it. If we thought there was enough demand...it would have been done a long time ago. The other thing is...there are no good spots. The spot you suggest is parking for the Village. Taking away parking will create so many more problems for the City...it's already maxed out. That location is so hidden too. I looked at that spot when the City asked me in 2004 to run a market.

I understand why people want to open markets in their neighborhood and it makes sense that the City of Capitola wants to have their own market but the reality is the economics don't work. If my Eastside FM was three miles down from where it is now...it could be officially be called the Capitola FM. We spent sixteen years building that site and it was touch and go for about ten. The market at Cabrillo is world class and has always been considered Capitola's market.

My suggestion is to promote the two markets that already exist and have a great following. I'm sure Catherine Barr, ED for MBCFA would agree with my position. Make sure you reach out to her. Feel free to call me if you would like to discuss more.
