Subject: Agenda Setting Procedures

Finance Department

Recommended Action: Receive report on agenda setting procedures and determine process going forward.

<u>Background</u>: Capitola's process for City Council Members to request agenda items is outlined in the City's Municipal Code (CMC) Section 2.04.140. As a summary, CMC Section 2.04.140 states any Council Member may request an agenda item during an open City Council meeting. On October 9<sup>th</sup> the City Council directed staff to amend the municipal code to require two City Council Members to agree in order to place an item on the agenda. However, the CMC does not outline agenda setting procedures for the Finance Advisory Committee (FAC).

<u>Discussion</u>: Staff periodically receive requests from individual FAC members to add agenda items to future meetings and have been advising those individuals to make the request during an open meeting. This has led to confusion that staff is controlling the items on FAC agendas as opposed to the committee members.

Establishing a defined process will greatly assist staff in the preparation of agendas including the timing of agenda items as well as increasing transparency and financial oversight.

Fiscal Impact: There is no fiscal impact associated with the recommended action.

**Subject:** Finance Advisory Committee 2025-2026 Goal Setting



<u>Recommended Action</u>: Receive report and establish 2025-2026 Finance Advisory Committee goals.

<u>Background</u>: The purpose of the Finance Advisory Committee (FAC) is to provide financial and budget alternatives to the City Council, provide financial and budget advice to the City Manager, conduct financial studies on the request of the City Council or City Manager, and review the budget and financial reports of the City.

<u>Discussion</u>: In March 2025 the City Council adopted the City's first five-year Strategic Plan. The strategic plan guides the City Council and community's shared vison for the future by focusing City resources on six strategic priorities through 2029. The six priorities are:

- 1. **Accountable Government:** We maintain the trust of our community by engaging residents through collaboration and effective communication while responsibly managing City resources to ensure long-term stability.
- 2. **Attainable Housing:** We will implement our Housing Element and infrastructure that balances diverse housing opportunities, supports varied income levels, and ensures thoughtful, community-focused attainable housing.
- 3. **Community Safety:** We will be a safe and resilient community, relying on the proactive training and expertise of our trusted police department to collaboratively provide public safety and emergency preparedness.
- 4. **Economic Opportunity:** We will create a thriving economy and maintain our regional shopping identity by supporting local businesses and national establishments in the Village, Bay Avenue, and 41st Avenue corridor.
- 5. **Healthy Families, Community, and Environment:** We will promote a thriving, inclusive city where families and individuals can grow together and connect in community spaces.
- 6. **Sustainable Infrastructure:** Our community will build and maintain safe streets, sidewalks, and public facilities that improve connectivity, fostering a vibrant City that is accessible and welcoming for all.

Establishing goals for the FAC that tie the committee's purpose to the City's strategic priorities will assist in establishing future meeting topics.
