

- Call to Order-Roll Call: Present: Johnson, Storey, Alioto, Wallace, Hill, Mozumder, Cahalen, Christiansen Absent: McPeak
- 2. Approval of Agenda- M/S Hill/Cahalen Approved Unanimously
- 3. **Oral Communications** Staff mentioned the upcoming Capitola Local Government Academy. Commissioner Cahalen talked about Capitola Village Cookie Stroll on December 7<sup>th</sup> and 8<sup>th</sup> and a Wine Stroll on February 8<sup>th</sup>.
- 4. **Approval of October 8, 2019 Minutes-** M/S Mozumder/Johnson. Approved unanimously.
- 5. General Business
  - **a.** <u>Youth Commissioner</u> Ayden MacKenzie has applied for the Youth Commissioner Position. Ayden gave his background and explained his interest. Chair Johnson asked how he found out about position. Ayden explained he found out about it from a local official. M/S Johnson/Wallace. Approved unanimously.
  - **b.** Events Review and Planning Staff reported on the proposed 2020 schedule.
  - c. <u>Plein Air (Verbal)</u> Commissioner Christiansen reported that the event was a great success. Received good feedback from artists, well organized. Saturday quick draw was great, added excitement. Hosting artists was successful. Commissioner Hill stated that the new quickdraw had 35 of 40 artists participating. Eleven pieces were sold for \$2900. Will make changes next year including commissions. Main event was great 15 artists sold 25 pieces for over \$12,000 and there may be additional sold after. Would like to lead next year. Jill Nelson did a great job with marketing.
  - **d.** <u>Plein Air Artwork for Marketing</u> Commissioner Hill reported that had used the winner of Plein Air in past, but Chris Potter allowed use this year. Normally artists license the use. He has offered the painting for \$500 and will allow for use in future material. M/S Hill/Cahalen to purchase the art. Approved unanimously.
  - e. <u>Battle of the Bands (Verbal)</u> Commissioner Wallace reported that he has met with Be Natural music school. Has received a lot of information from them. Chair Johnson asked if subcommittee has met. Commissioner Wallace will have subcommittee meet, Looking at 6-10 bands. Commissioner Hill suggested an invitational and suggested donation rather than charging.
  - **f.** Monterey and Wharf Railings (Verbal) Chair Johnson reported that he and Commissioner Cahalen met to see the railing. It is a big project. Will need to determine the next steps. Staff will send Chair Johnson Planning Commissioner Wilk's contact information.

### **BACKGROUND**

The Art & Cultural Commission consists of nine members, currently there are three (3) atlarge positions with terms ending on January 1, 2020

The Capitola Municipal Code requires that the commissioners be appointed by the City Council upon recommendation by the Art & Cultural Commission and shall serve a two-year term. According to the Bylaws, members do not need to be Capitola residents. At the September 26, 2019 City Council meeting, term limits for Commissioners were removed from the Art and Cultural Bylaws.

The Commission recommendation for re-appointment will be set for approval at the December 19, 2019 City Council meeting.




