- 1. Call to Order-Roll Call: Present: Johnson, Storey, Alioto, Hill, Cahalen, McPeak, Christiansen

- 2. **Approval of Agenda** Request to add virtual twilight concerts as item 5.c M/S Storey/Cahalen Approved Unanimously
- 3. Oral Communications- None
- 4. **Approval of May 12, 2020 Minutes-** M/S Storey/Alioto. Approved unanimously.
- 5. General Business
  - a. <u>Plein Air Commissioner Hill reported that she has reached out to the artists to</u> see if they have interest in a scaled down event. Most are positive, will get back to them after July 1. Looking at October 25<sup>th</sup> at a date at Jade street park. Better for scale of event. Commissioner McPeak stated that there was positive energy at the subcommittee meeting. Commissioner Christiansen commented that that there was some hesitation, but that may change. Commissioner Hill added that they will look for local artists that would participate. Commissioner Cahalen suggested that it be call the event an invitational and look for help from artists. Commissioner Hill replied that it would be something to look at, will know more after July 1. Chair Johnson commented that he liked the scaled back version and recommended moving forward. Commissioner Storey added that he would like the subcommittee to move forward cautiously. Commissioner Hill stated that the public art fund could still be used to purchase the art. Some funding will be need for the marketing. Chair Johnson felt that advertising could be cut back. Commissioner Hill stated she was not sure how to catalog the art online. Commissioner Hill stated they will come back with more information in July.
  - **b.** <u>Public Art Projects (Verbal)</u> Commissioner Cahalen reported on the stair mural and will go out to a call to artists. Staff will work with Commissioner Cahalen on any questions. Chair Johnson reported that the Monterey Ave railing subcommittee has not met, will schedule a meeting.
  - c. <u>Virtual Twilight Concerts</u> Alex Lucero presented the idea of live streaming concerts from a closed location as a way to keep music alive in the community. Has successfully done shows and can sent the stream anywhere to multiple sites, Facebook, YouTube. Can use any closed business, just need wi-fi. Commissioner McPeak asked about playing outside. Chair Johnson asked about other bands. Alex Lucero responded that that he has spoken with Joint Chiefs, Locomotive Breath, and Everyday People. Commissioner Hill asked about safety and wanted to make sure that protocol is followed. Commissioner Storey mentioned the Wharf House as potential site. Commissioner McPeak was concerned about the potential crowds. Commissioner Storey also mentioned Monarch Cove as a potential site. Concerts will take place at same

time as Twilight Concerts, Wednesdays 6 pm -8 pm. Subcommittee members will be Commissioners Alioto and McPeak.



# Call to Artists Depot Hill Stairs Mural

Request for Qualifications

Date Issued: June 22, 2020 Submittal Deadline: August 3, 2020; 5 p.m.

Call to Artists: The Capitola Art & Cultural Commission is requesting qualifications from muralists who will be selected to design and produce a mural on the stairs leading to Depot Hill from Capitola Village. The mural will be painted on the vertical risers of the concrete stairs leading to Depot Hill. The stairs are located between Capitola Village and Depot Hill. The begin at El Camino Medio in the village and end at Cliff Avenue on Depot Hill. The artist selection will be a two-step process: first, the Commission will screen the qualifications and select up to 4 mural artists to develop a design proposal; second, one artist's design will be selected by the Art and Cultural Commission and submitted for final approval by the Capitola City Council.

Vision: The stairs are used by the public at all hours of the day and night. They are used for exercise, as well as a way to walk from the Village to Depot Hill. The Art and Cultural Commissions vision is to have a mural that is seen from the bottom to the top. The stair tread needs to have the required contrasting stripe. The mural needs to reflect the feel of the Village and Capitola.

Scope of Work: The Depot Hill stairs leading from Capitola Village to Depot Hill are 6 - 8 feet wide and have a rise of approximately 52 feet and a run (length) of approximately 90 feet. There are 86 stair risers and each one is approximately 7 inches in height. The total surface area for the stair risers is approximately 450 square feet. There is no possibility of there being any improvements to the stairs or the handrail. The riser will be where the mural will be painted. The stair construction is concrete. Photographs and Maps of the location are in Attachments A and B

Other Elements and Background: The mural artist will be responsible for design, delivery and installation of the artwork within the given budget and timeframe. This includes using appropriate paints for the surface, weather and painting a sealant on top of the mural that seals for the weather and graffiti resistance. The mural is expected to have a lifespan of at least 10 years. The artist will need to work with the City to determine maintenance needs of the mural.

<u>Part 1: Design Proposals</u> - The artist(s) selected to propose a mural design will be responsible for preparing a design and presenting the design for review and approval by the Art and Cultural Commission. The design shall include a mock-up of the proposed mural design with sketches of the mural details. The Commission will decide the mural design to recommend to the City Council for approval.

<u>Part 2: Mural Design and Construction</u>- The artist selected to design and construct the mural will be responsible for:

- Preparing the design and modifying the design per Art and Cultural Commission, City Council and city staff direction;
- Preparing and priming the stairs if necessary, for the mural;
- Providing all materials, including scaffolding or other equipment;
- Painting the mural;
- Providing any necessary security during the mural construction;
- Graffiti coating the mural; and,
- Completing the mural within the specified timeline and within budget.

The City of Capitola will be responsible for:

- Reviewing and approving the final design;
- Providing any access control; and,
- Serving as a resource during project construction.
- Project Budget: Each artist selected to propose a mural design will be paid \$250, which includes all time and materials. The artist selected to design and construct the mural will have a project budget is \$10,000, which shall include all expenses, including but not limited to: design and artist's fee, all applicable fees, priming, materials, labor, required insurance, travel and expenses, scaffolding and graffiti coating.

Artist Selection Criteria: Open to all artists based in Northern California. Artists will be selected based on the following criteria:

- Creativity and innovation of design;
- Design theme;
- Relevance of the image to the project site;
- Artist's demonstrated ability to produce the proposed artwork within the defined timeline and budget; and,
- Artist's experience in mural art and working for public or private entities.

Project Selection Panel and Selection Process: A selection panel will review the artist qualifications and recommend selection of up to 4 artists for submittal of a design proposal. It will be comprised of Public Art Committee members, City staff and community members. The City's Art and Cultural Commission will review and rank the design proposals. The Commission will select the mural design to recommend to the City Council for approval.

The Commission reserves the right to change the project timeline.

#### Submittal Guidelines:

- 1. One-page cover sheet stating the following information, in the order listed:
  - Title: "Depot Hill Stairs Mural"
  - Artist's Name
  - Artist's Phone Number
  - Artist's Email Address
  - Artist's Mailing Address
  - Artist's Website if applicable
- 2. Resume of not more than two, double-sided pages that demonstrates experience as an artist.
- 3. Images Artists may submit up to 10 color images on paper or digitally exhibiting examples of his/her mural art.
- 4. Mural Concept Provide a proposed concept and theme for mural, with rough sketches.
- **5.** References Names, phone numbers and addresses of three professional references, with artist's name noted at top of page.

Application Deadline: Applications and submission must be by 5 p.m. on August 3, 2020. Applications received after the date and time indicated herein shall not be accepted and requests for extensions of closing date or time will not be granted. Applications may not be modified after submission.

**Legal info:** This call for artists does not constitute a guarantee that the City will hire an artist. The City may decide at its discretion not to select any of the proposers and/or reissue the call for artists.



SUBJECT: "Virtual" Twilight Concerts

**Recommended Action:** Receive Report

**BACKGROUND** At the June Art and Cultural meeting, the Commission approved working with Alex Lucero to create "Virtual" Twilight Concerts to view on the Internet. The purpose of the concerts is to give the musicians an audience for their music.

On July 1, Alex Lucero and Live Again played and on July 8, Locomotive Breath played. Both concerts attracted more that 2,000 views on the Art and Cultural Commission Facebook page. A Facebook account is not required to view the concerts. In addition, Santa Cruz Waves has also streamed the concerts and they have had approximately 5,000 views on their Facebook page.

The next concert will be on July 15<sup>th</sup> and The Joint Chiefs will be the band. Staff is working with Alex Lucero to determine how many concerts can take place. The City does not have the skills or equipment to run the concerts without his expertise.
