Wharf Rd. Mural Extension

RECOMMENDED ACTION: Approve further development of artist concept by Muralist John Ton for the Wharf Rd. Mural Extention Project.

BACKGROUND

The Wharf Road Mural was completed in 2012 by Mural Artist John Ton. In response to the Commissions request, Mr. Ton was contacted regarding extending the mural to include the retaining wall near the railroad trestle.

Upon the Commission's approval and further direction, John Ton will develop a more detailed concept, which will be presented to the Commission for approval. Once a design is approved by the Commission, it will be presented to the City Council for final approval.

FISCAL IMPACT

The artist estimates the cost will be \$800 for concept development and \$5,000 for mural.


Thanks for your persistence and patience! - here are some ideas going forward with the mural extension:

- (1) As far as I am aware, the consensus of the public is that the existing mural is well received and is "inclusive" in that it represents the artist's intent to resonate with the public and be "the public's mural" if you will. You might say that it is "easy on the eyes". In that light I suggest continuing the successful, recognizable theme of portraying people in candid poses / activities (such as "stroller mom" and "wagon grandpa" and "photographer" as portrayed in the first mural.
- (2) The begonia theme is also well received and recognizable; this, too ought to be in the forefront of our thoughts moving forward.
- (3) This artist would appreciate a budget proportionate to the previous mural commission. A \$5000 budget would be appropriate.
- (4) Depending on a host of variables due, in part, to the selection committee being so large, this artist would hope for a smaller liaison group entrusted with actual commissioning of the mural.
- (5) An initial artist's fee for preparation of one or two concepts reflecting the above comments would be \$800 this fee would be paid to the artist regardless of whether the committee ultimately approved / selected me for the work.

SUBJECT:

Graphic Traffic Box Maintenance

RECOMMENDED ACTION: Approve maintenance of the Graphic Traffic Boxes by artist Bruce Harmon for an amount not to exceed \$4,075.

BACKGROUND

The Graphic Traffic Box Project was completed in 2009 by Artist Bruce Harmon. This project included the painting of eight traffic signal cabinets with sea life scenes. These boxes have experienced some minor damage and routine weathering over the last five years. Staff is recommending a deep cleaning, touch up paint and a thick top coating of a UV protection material to maintain the artwork on each box. In addition one of the boxes (Capitola Rd. and 41st Ave). was replaced recently and the new cabinet will be re-painting with the original scene (Seal).

FISCAL IMPACT

The artist budget for the project is \$4,075



About the anti-graffiti coating that would be used:

After doing research, it seems that cost is directly proportional to effectiveness in these coating. The brand I would use is POR-15, a two-part resin that is used in automotive restoration mostly, but also in anti-graffiti applications. It costs \$200 per gallon!

The coating that was used on these boxes initially showed itself to be less than optimal when I tried cleaning off a tag. I will be doing a test in the next two weeks to assess its ability to withstand strong solvents that can remove most any type of graffiti.

If the product proves to be as good as they say, it will give a high gloss that is super durable, resistant event to hammer blows and will last for years.
