
#### **DRAFT MEETING MINUTES**

- 1. Call to Order-Roll Call: Present: Termini, Hill, Hogan, Smith, Cahalen, Cross, Storey Absent: Norton
- 2. Approval of Agenda- M/S Storey/Cahalen Approved Unanimously
- **3. Oral Communications** Commissioner Hill asked about retaining wall on Park and Washburn. Elaine Kennedy with Art of Santa Cruz in the Capitola Mall discussed the restarting of the third Friday event at the Capitola Mall. Staff will send application for banner.

Mike Arnone will present options for the location and size of the climbing sculpture. The Commission will need to form a subcommittee and create a call to artist for the sculpture.


**FISCAL IMPACT** The recommended size of the sculpture will affect the budget of the sculpture. It is anticipated that the budget will be less than \$50,000.




Esplanade Park 4x4 Option 5' Diameter Option 6 x 8 Option





The Commission receive presentation and action will be taken at the May meeting after all commissioner have had an opportunity to review the proposal.


**FISCAL IMPACT** Each artist will be paid a stipend of \$500.00 dollars will be given for their proposal.

SUBJECT: Plein Air

**Recommended Action**: Receive Report and Give Direction

#### **BACKGROUND**

At the March 14, 2017 meeting, the Commission directed staff to begin discussions with former commissioner, Jenny Shelton, on the possibility of running the Plein Air event in 2017. Ms. Shelton has been deeply involved in the event for the first two years of its existence. In 2016, she was the chair of the Plein Air committee. In 2016, the event expanded and required more time and effort to coordinate.

Based on the time and effort required to put on the event, staff believes that it would be best to contract with Ms. Shelton so that Plein Air continues. Ms. Shelton has given the City an estimate of \$3000 to coordinate and run Plein Air. Ms. Shelton estimates that the event will require approximate 200 hours of her time.

Ms. Shelton would be responsible for planning, marketing, securing sponsors, and running the Plein Air event. The plan and work will be coordinated through the Plein Air sub-committee, with members of the Art and Cultural Commission. The workplan and expenses for the event will need to be approved by the sub-committee.

The 2016 Plein Air event had expenses of approximately \$10800 of which the City Budgeted \$3500 from the general fund and \$2300 from the public art fund to acquire the winning paintings for the city's permanent collection. Revenues for the 2016 event were \$8000.

**FISCAL IMPACT** The proposed agreement to run the Plein Air event will be for \$3000 plus approved expenses.
