

The three selected artists to present their proposals at the November 14, 2017 Commission Meeting for consideration.


Staff will take the recommendation of the Commission to the City Council for consideration.

The evaluation of the area has been performed and it has been determined that the project can proceed. Staff will bring the project to the City Council meeting on October 12, 2017 for consideration.


The artists will be attending the Council meeting on October 12.

SUBJECT: Commissioner Recruitment

Recommended Action: Receive Report

**BACKGROUND**; The Art and Cultural Commission has nine seats. Currently the Art and Cultural Commission has eight members, the Arts Professional Commissioner seat has been vacant since January 1, 2017. Five of the current commissioners have terms that expire at the end of 2017. Vice-Chair Cross will not be eligible to re-apply due to term limitations. The four other commissioners can re-apply for their existing seats.

The City will continue recruitment for the Arts Professional seat and has started the recruitment process for the expiring seats. Previously termed-out Commissioners who have not served on Commission for the most recent two-years are eligible to re-apply.

We have received applications from three of commissioners that are eligible to re-apply. The City has not received any other applications.

FISCAL IMPACT; There is no anticipated fiscal impact
