

- 1. **Call to Order-Roll Call**: Present: Termini, Hill, Norton, Cross, Storey, Connolly, Cahalen, Norton Absent: Hogan
- 2. Approval of Agenda- M/S Cross/Cahalen Approved Unanimously
- 3. **Oral Communications** Rick Gross in attendance. Kelly Barreto in attendance. Commissioner Norton met with Ed Kroupa regarding orbs presented at 11-14 meeting. He has the rights to recreate. Chair Termini suggested it be added to retreat discussion.
- 4. **Approval of November 14, 2017 Minutes-** M/S Cahalen/Cross. Approved unanimously
- 5. General Business
  - a. <u>Bylaw Changes</u> Staff will communicate with schools on recruitment of youth members. Commissioner Cross recommended only high school students. M/S Storey/Cahalen Approved Unanimously
  - b. **2018 Meeting Dates** Staff reported on the meeting dates. Second Tuesday of month, except for January, which will be on the third Tuesday.
  - c. <u>2018 Commissioner Appointments</u> Commission discussed applicants. M/S Cahalen/Norton to recommended to the City Council Roy Johnson as Arts Professional, Mary Jo Connolly as Artist and Rick Gross and James Wallace as At-large Commissioners. Approved Unanimously.
  - d. <u>Plein Air Verbal</u> Commissioner Hill reported on Plein Air 2018. 40 artists participated. 26 pieces of art, valued at \$8800 were sold. There is a post event show of the painting at Wargin Wines. Fairfield Inn is displaying the 2017 winner in their rooms. Event is not covering costs yet. Commissioner Norton asked if it could be a goal to be profitable. Commissioner Cross believes goal should be cost neutral. Rick Gross believes there are opportunities for revenues. Chair Termini asked if more panels could be made so more work could be displayed and sold.
  - e. <u>Art Donation Staff</u> reported that artist has offered a piece of art to the City. Staff will follow up with artist.

According to the by-laws:




