- 2. Approval of Agenda- M/S Storey/Connolly Approved Unanimously
- 3. **Oral Communications** Christina Evans and Julie Norton with the Mosaic with Meaning Community project spoke to the Commission about finding a location for a Mosaic tree project that the group is working on. They invited commissioner to come look at the project.
- 4. Approval of January 26, 2017 Minutes- M/S Storey/Gross. Approved unanimously
- 5. General Business

  - c. <u>Sea Ball Art –</u> Commission discussed the proposed Sea Ball artwork by Ed Kroupa, which included four relief marine themed balls to be installed along the Esplanade wall near beach entrances. Commissioner Storey was not in favor because it would displace space kids use. Would like to get a better idea of how it would fit into the location. Commissioner Connolly like the tactile nature of the work and felt the it could be educational. Commissioner Hill suggested maybe two would work better and we could see how it looked, was also concerned with it blocking the view from the beach. Commissioner Johnson felt two toward the center would be good. Staff will communicate with the artist.
- 6. **Commissioner Reports** Commissioner Hill reported that the Begonia festival would like to work with the Commission on a public art project. Begonia festival will contribute \$20,000 and would like a match from Commission. Chair Termini suggested this be brought to the May meeting.

SUBJECT: Sea Ball Art

#### Recommended Action: Give Staff Direction

**BACKGROUND** One of the finalists for the Esplanade Park Sculpture was Ed Kroupa. His proposal was not selected for that project; however, the work was well liked and the Commission expressed interest in the work at other locations. Commissioner Norton met with the artist to discuss the potential for the work to be installed at some of the openings to the beach at Esplanade Park.

At the March Commission meeting it was requested that the item be put on the April Commission Agenda for direction. The proposed cost for the art is approximated \$14,000 per ball and an additional \$2000 for installation for a total of \$58,000 for the project.

At the April Commission meeting staff was asked to contact the artist to check on the cost of two instead of four. The cost for each ball and installation would be the same. The total cost for the two sea balls will be approximately \$30,000

Currently, the Public Art Fund has a balance of approximately \$150,000 which includes the commitments to the three outstanding Public Art Projects.


#### FISCAL IMPACT

Cost of the four Sea Balls is approximately \$58,000 including installation. Those funds would come from the dedicated public art funding.



SUBJECT: Begonia Festival Committee Donation

**Recommended Action:** Recommend Accepting Donation to City Council

**BACKGROUND** At the April Commission meeting, Commissioner Hill requested that proposal from the Begonia Festival Committee for a public art project be considered by the Commission. The Begonia Festival has proposed that a public art project to memorialize 65 years of the Begonia Festival be installed in Capitola.

The Begonia Festival Committee has proposed donating \$20,000 to the City for the project, with an equal amount coming from the Public Art fund for the project. To accept the donation greater than \$5,000.00, it must be approved by the City Council. If the Commission recommends receiving the donation, staff will bring the donation to the May 24, 2018 Council meeting for approval.

If the donation is accepted by the Council, the Commission can form an art selection subcommittee to decide on a potential location and create a Call-to-Artists.

#### FISCAL IMPACT

The Begonia Festival Subcommittee is offering to donate \$20,000 of a \$40,000 for public art project memorializing the Capitola Begonia Festival.

### Artwork

The City of Capitola is looking for proposals for a Sculpture to Memorialize 65 years of the Capitola Begonia Festival. For 65 years from 1952 to 2017, the Capitola Begonia Festival brought family and friends together for a long weekend of fun. The Festival included events such as the Nautical Parade down Soquel Creek, Horse Shoes, Sand Sculptures, Chalk Art, Concerts, Movies on the Beach, Fishing Derby, Children's Art, Rowboat Races, and much more. For a historical perspective you can access the website at www.begoniafestival.com for photos, programs, poster art, etc.

### Site & Project Description

Capitola Village is located along a wide beach with a breathtaking view of Monterey Bay and is home to numerous craft galleries, boutiques and restaurants. It is here where many events take place. One of the largest events was the Capitola Begonia Festival. The Begonia Festival and the City of Capitola would like to create a sculpture to memorialize the spirit that this Festival brought to the City for over six decades. While the ideas for a sculpture are endless, at the very least, it should incorporate begonias. The installation of the sculpture will be done in conjunction with City of Capitola Public Works. The sculpture will be installed in a marine environment, so materials used should be very weather resistant. Location will be \_\_\_\_\_\_ (TBD).

### PUBLIC ART PROJECT BUDGET

The public art project budget is \$40,000. (\$20,000 from Capitola Begonia Festival matched with \$20,000 from the Art & Cultural Commission).

The project budget includes all expenses related to the research, investigation, design, fabrication of the artwork including, but not limited to: design time and fees; design documents, renderings and/or other media as required to communicate artist's concept design development to stakeholders and approving bodies; signed and certified structural, and/or other construction/engineering drawings and specifications, that may be required for fabrication; fabrication of the artwork; transportation of materials, transportation and accommodations for artist(s); insurance and all other project related expenses. The artist will work with the City in the installation of the artwork.

### ARTIST ELIGIBILITY

This opportunity is open to artists working or living along the west coast of the United States in California, Oregon, Washington and Hawaii. *Applicants must be able to demonstrate that they have all necessary permits to work in the United States at the time of submittal of qualifications.* 

### SELECTION PROCESS AND EVALUATION CRITERIA

This is a concept proposal selection; the process for this project has two phases:

### Phase One: Review of submittals and selection of finalists

A Capitola Begonia Festival Sculpture Committee that includes members of the Art and Cultural Commission, community members, representatives of the retail district, and visual arts professionals will review submittals and recommend up to four finalists.

# Phase Two: Development and Presentation of Concept Proposals by Finalists and Concept Proposal Selection.

The selected finalists will be asked to prepare a detailed concept proposal for the project.

It is expected that each finalist will make a concept proposal presentation in-person to the Public Art Project Committee. The concept proposal presentation session will be scheduled to accommodate the selected finalists if possible, but final date selection will be at the discretion of the City.

The selected finalists will be provided a stipend to help prepare and present the concept proposal.

### **CRITERIA**

Consideration of artists in the selection process will include but is not limited to the following:

- Aesthetic excellence of past projects
- Appropriateness of prior concepts as they relate to Public Art and the Capitola Begonia Festival Sculpture Art Project goals and setting
- Experience developing artworks in outdoor environments
- Experience in construction materials and methods appropriate to the scope of the project

### CONTRACT

The City of Capitola will contract with the artist in a single agreement using a standard design-fabrication agreement. A prototype of this agreement will be available to the selected finalists. Final award shall be contingent upon selected artist accepting Terms and Conditions of the agreement in substantial conformity to the terms listed in the prototype.

The selected artist must comply with any local business licensing requirements.

### APPLICATION DEADLINE

Submissions (described below) must be received as a complete application in CaFÉ<sup>™</sup> by no later than **12 p.m. PDT on Monday**\_\_\_\_ **2018.** 

### APPLICATION PROCESS

All materials will be submitted online, via CaFÉ<sup>™</sup> (www.callforentry.org). There is no application fee to apply or to use the CaFÉ<sup>™</sup>. To view the application, go to www.callforentry.org, register a username and password, navigate to "Apply to Calls", and search the list for "Capitola Begonia Festival Sculpture". ### **REQUIRED APPLICATION MATERIALS**

The application submission must include the information and materials described below all of which are required to constitute a complete application. Please review carefully as incomplete applications will not be eligible for consideration and will not be reviewed.

**1. Summary of Experience:** Submission shall include a brief summary of relevant past experience

**2. Résumé + References:** Submission shall include a current résumé that outlines your professional accomplishments as an artist. Please include at least 2 references of your professional work.

**3. Images of Past Work:** Submission shall include visual representations of past artwork that demonstrate your qualifications for this project. To be considered for this project, the applicant shall at least 6 digital images that represent a minimum of 3 completed projects; each image must include information about: a) location of work, b) year of completion and c) cost of work; if the image is of work created by an artist beside or in addition to yourself, include a clear statement about your actual role in the creation of the work.

**4. Descriptions of Past Work:** Submission shall include a list of the submitted project images with descriptions that clearly explain both the projects and images. Please indicate title, date, location, dimensions, significant materials, and budget if a public commission. If you were the member of a team, please indicate your role in the project.
