

- 2. Approval of Agenda- M/S Connolly/Storey Approved Unanimously
- 3. **Oral Communications** Commissioner Hill does not recommend pursuing the donated art from the Scotts Valley Art Walk

Chair Termini commented that maybe it could happen in conjunction with the Mall redevelopment.
  - **c. Plein Air (Verbal)** Commissioner Gross reported that they have agreed with returning sponsors. Operations manager at David Lyng might join the committee.
  - d. <u>Sea Ball Art –</u> Chair Termini asked if there was a preference to which two of the sculptures fit. Commissioner Storey still feels that they do not fit in with the location and that people use the wall and we would lose that. Commissioner Connolly felt that the pillar should be improved, possibly painted. Commissioner Connolly motioned to install the Starfish and Crab designs. Seconded by Commissioner Wallace. Approved 7 1, with Commissioner Storey voting no.
  - e. Begonia Festival Public Art Donation Commissioner Hill reported that the Begonia Festival board would like to partner with the Commission on a Public Art project to commemorate the Begonia Festival. Art would be located in the village. The Begonia Festival will donate \$20,000 to the City if the City matches it from the public art fund. Commissioner Storey motion to recommend to the City Council to receive the donation for the project. Seconded by Commissioner Connolly. Approved Unanimously.

SUBJECT: Begonia Festival Public Art Project

**Recommended Action**: Nominate a Subcommittee

#### **BACKGROUND**

At the April Commission meeting, Commissioner Hill requested that proposal from the Begonia Festival Committee for a public art project be considered by the Commission. The Begonia Festival has proposed that a public art project to memorialize 65 years of the Begonia Festival be installed in Capitola. The Begonia Festival Committee has proposed donating \$20,000 to the City for the project, with an equal amount coming from the Public Art fund for the project.

To accept the donation greater than \$5,000.00, it must be approved by the City Council. At the May Commission meeting, the Commission recommended to the City Council to accept the donation from the Begonia Festival Committee for a public Art Project. At the May 24, 2018, City Council Meeting, the Council unanimously approved accepting the donation.

The Commission should form an art subcommittee to recommend locations and type of art project, and budget to the full Commission. When the full Commission approves those parameters, a Call-to-Artists can be issued for the project.

#### FISCAL IMPACT

The Begonia Festival Subcommittee is offering to donate \$20,000 of a \$40,000 for public art project memorializing the Capitola Begonia Festival. The \$20,000 contribution from the City will come from the Public Art fund.
