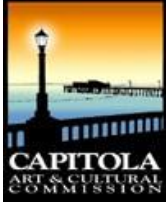

### **BACKGROUND**

Recently the Art and Cultural Commission approved four public art projects. This report is to update the Commission on the status of the projects.

- Capitola Avenue Railing Project; Sculptural Accents completed the railing project in May 2018.
- Monte Family Skatepark Mural; Taylor Reinhold and Jimbo Philips began working on the project and completed most of the mural. Unfortunately, Taylor suffered an injury and has just started painting again. He will get the mural finished as soon as he can.
- Esplanade Sculpture; Kim Chavez Bronzeworks has finished the Sea Lion Sculpture at Esplanade Park and the rubber surface has been installed. The name of the sculpture is Embrace. Staff will be installing a plaque that acknowledges the artist and also one that warns that the sculpture may be hot.
- Esplanade wall sea relief sculptures by Ed Kroupa. Staff will be bringing the project to the City Council on November 20, 2018 for consideration. The commission recommended the Starfish and Crab designs. The relief sculptures will be installed at one of the entrances to the beach.
