H. Demo plans

- 1. For remodels and additions a demolition plan shall be submitted showing all areas of walls and floors to be demolished clearly identified in the drawings and a work scope statement. The city may require a letter from a Structural Engineer.
- 2. Any modifications to the demolition plans, including modifications to the scope of work, means and methods of demolition/construction, or changes to the framing, windows or any exterior elements shall be submitted to the Building Department for Review and Approval prior to proceeding with demolition and/or construction. In the course of construction, the City may require additional plans as they deem necessary
- 3. The following agencies may require clearance before starting project, if applicable:
