### CURRENT OPENING

The Capitola Recreation Department is currently accepting applications for the position of Junior Lifeguard Instructor/Lifeguard for our Summer Junior Lifeguard program. The Junior Lifeguard Instructor/Lifeguard is a Part-Time/Seasonal position from March-September, not to exceed 960 hours in a calendar year. Candidates for the Junior Lifeguard Instructor must be available to work a full-time schedule (40 hours per week) for the summer months (June through August). The start date of the Junior Lifeguard program is June 18<sup>th</sup>.

#### DUTIES

Under the supervision of the Beach Captain or the Junior Lifeguard Coordinator, will act as an instructor and leader for the Junior Lifeguard program and as assigned will be responsible for beach safety while staffing the Lifeguard Towers on Capitola Beach. The Junior Lifeguard Instructor/Lifeguard will work with the Junior Lifeguard Coordinator to organize, implement and supervise Junior Lifeguard events and competitions, including sports, fitness, and swimming activities. The instructor is responsible for the safety and conduct of the group of children in his or her care on the beach and in the water. He or she should be comfortable working individually or as part of a team. The Junior Lifeguard Instructor/Lifeguard will be fully trained to understand and perform Open Water Lifesaving duties.

### **REQUIRED QUALIFICATIONS**

- 18 years of age.
- EMT certification is highly desirable.
- Excellent health.
- The ability to complete a 500m ocean swim time of under 10 minutes.
- Vision 20-30 corrected.
- California Driver's License (valid).
- Criminal history and fingerprint check.
- Successful completion of Capitola Lifeguard training program after initial hiring process is completed. Successful completion and maintenance of required medical training certificates.
- Meet the minimum requirements for a USLA open water lifeguard.
- Proof of negative tuberculosis test or clear chest X-ray must be presented within 14 days of hire.

#### DESIRABLE QUALIFICATIONS

Two years' participation in a Junior Lifeguard program.

Ability to: perform effectively in situations requiring specialized knowledge and safety precautions, using tact and good judgment; follow the program guidelines and perform to standard; understand and carry out oral and written directions; communicate effectively with children, parents, and other staff; be versatile, flexible, friendly, cooperative, and willing to learn new skills; be a positive role model. Previous experience working as a lifeguard (particularly on the beach) or a Junior Lifeguard instructor; lifeguard training or certification; E.M.T.

#### TRYOUTS AND TRAINING

Tryout and requalification swims will take place on the following dates;

- March 31<sup>st</sup>
- April 7<sup>th</sup>
- April 14<sup>th</sup>

Additional swim dates may be added if determined to be necessary.

Required training will take place the weeks of June 4<sup>th</sup>- June 8<sup>th</sup> or June 11<sup>th</sup> – June 15<sup>th.</sup> You will be notified by the Beach Lieutenant/Junior Lifeguard Coordinator with the exact date(s) & time(s) closer to the start of the season.

#### SALARY/WORK SCHEDULE

The program is held at Capitola Beach and runs from mid-June through mid-August. In addition to completing the Capitola training and testing, and obtaining all certifications, all Junior Lifeguard staff will be required to attend an orientation session on the weekend prior to the start of the program, and any other additional training sessions required throughout the season.
