Two (2) Members of the City Council
Each for a full term of four years from December 2020 to December 2024

Qualifications for Office: Prospective candidates must be registered voters within the City of Capitola at the time nomination papers are pulled [Elections Code §201].

Where to obtain and file official declarations of candidacy: Eligible candidates may obtain official forms from the City Clerk at Capitola City Hall, 420 Capitola Avenue, Capitola, CA 95010. Completed forms must also be filed with the City Clerk. Appointments are needed to obtain and file papers.

Filing Period for Nomination Papers: The filing period for nomination papers is from Monday, July 13 through Friday, August 7, 2020, at 5 p.m. Appointment to elector office: In the event there are no nominees or insufficient nominations for an election, the time period for election official with the time period prescribed by California Elections Code §10515 (b) 5:00 p.m. on the 8th day prior to the day fixed for the election, August 12, 2020, then appointment to elector office will be made as prescribed by Elections Code § 10515

Lots Drawn in Case of a Tie: In case of a tie vote, the winner shall be chosen by lot [Elections Code §10551(b)].

This election will be consolidated with other state and local elections. The polls will be open between the hours of 7 a.m. and 8 p.m. on Tuesday, November 3, 2020.
