

City Still Addressing Winter Storm Damage

While the City of Capitola escaped this past winter's fury with fewer impacts than our neighboring jurisdictions, the City did suffer damage along Park Avenue, the upper portion of Esplanade Park, the Wharf, and along the Depot Hill bluffs.

The damage to Park Avenue, where several large trees fell across the road, has required the closure of the bike lane. Fortunately, much of the repair costs to Park Avenue will be paid for by federal emergency funds. However, those federal funds require a more complicated process to design and bid the project; as a result, the repair work is anticipated to begin in Spring 2018.

Landslides on the cliff below Depot Hill have resulted in the partial closure of the Grand Avenue pathway and the upper portion of Esplanade Park at the bluff base. A geologist has advised the City to keep both areas closed while corrective measures can be developed to protect the public.

Plans for securing the upper portion of Esplanade Park are underway and that area should be reopened late this summer. The Grand Avenue pathway, on the other hand, will likely remain closed for the indefinite future as long-term plans are evaluated. City Council will receive an update regarding those options this fall.

On the Wharf, pilings holding the floating dock were damaged in late April. An emergency contract has been awarded for the repairs and the work should be completed by mid-July.

New Capitola Branch Library Taking Shape

The design of the new Capitola Branch Library is moving forward right on schedule. The architects are now working on detailing the design and making this Capitola's library. Below is a draft look at the children's area, with a colorful ceiling and large windows overlooking a deck and the tot lot. Groundbreaking at the Wharf Road location is anticipated in 2018.


Draft Zoning Code Update Now Available for Public Review and Comment

The City of Capitola released the draft Zoning Code update for a 60-day public review period on May 31. The draft is available for review on the City website, at City Hall, and at the Capitola Branch Library. The comment period closes August 1. The Planning Commission is scheduled to begin the final adoption process for the new code on September 6.

In late August, property owners and residents will begin to see mailed and posted notices around the City. These will give an overview of changes to an area's zoning as part of the overall update and announce hearing dates.

The City initiated the process to update its 1975 Zoning Code in 2014 and has since held more than 40 public hearings and workshops. The Zoning Code regulates how land may be used; controls the type, size, and height of buildings; and establishes standards for design, parking, signage, and other matters of local importance.

The Zoning Code update strives to promote high-quality design, protect neighborhood character, and comply with current legal standards in a manner that is easier to understand, administer, and enforce. The updated Zoning Code will also implement the goals, policies, and actions of the recently adopted General Plan Update. ADA Plan Review Looks at Capitola's Accessibility

The City of Capitola is currently in the process of updating its Americans with Disabilities Act (ADA) Transition Plan and Self-Evaluation Plan. This plan identifies accessibility deficiencies in the City's facilities, rights-of-way, and services, and provides a timeline and cost estimate to correct any issues.

This process allows the City to ensure that all residents and visitors can enjoy everything that Capitola offers equally, without discrimination to persons with disabilities.

The evaluation and update began in June 2016, and is scheduled to be completed in two phases. Phase I consisted of the evaluation of all the City of Capitola facilities and parks,

while Phase II will consist of the evaluation of the public rightsof-way and the services provided by the City. Phase I is nearly completed and Phase II will begin in July 2017.

Once Phase II is complete, the City will hold a public outreach meeting, currently scheduled for January 2018. It will help identify the most frequented facilities and services used by the public, and ensure they are given a higher priority.

Following that public input, the final draft of the plan will be presented in a public hearing before the City Council. Interested members of the public are encouraged to participate in the process. Please contact the Building Division at 831-475-7300 for additional information.

Capitola Becomes Founding Member of Monterey Bay Community Power

Monterey Bay Community Power (MBCP) is a new regional partnership between local governments that plans to provide electricity to residents and businesses throughout Santa Cruz, Monterey, and San Benito counties starting in Spring 2018.

MBCP aims to improve consumer choice, increase renewable energy, and stimulate the regional economy by reinvesting in the community.

In February 2017, local government boards, including the City of Capitola, passed an ordinance to form MBCP. The first meeting of the new board of directors was held in May. This summer MBCP will hire its first CEO, as well as continue community outreach and planning for a Spring 2018 launch.

This exciting project grew from approximately 100 community meetings, as well as in-depth focus-group meetings with elected officials and staff from every city and county in the three-county region. Eventually 19 jurisdictions chose to join MBCP, including the City of Capitola.

In Capitola's Climate Action Plan, the most significant opportunity for the community as a whole to reduce its greenhouse gas emissions is for the City to partner with other local governments to establish a public sustainable-energy partnership. MBCP is that entity and will allow City residents and businesses to choose clean-source electricity at a cost equivalent to PG&E. PG&E will continue to provide gas and customer service, including billing, and to maintain power lines.

This nonprofit model helps boost local economic vitality because the money from rates paid by customers stays local, helping to fund regional renewable energy projects and create jobs.

This Fall local PG&E customers will be notified about how the transition to MBCP electricity will work. Customers may remain with PG&E if they wish. Visit mbcommunitypower.org to learn about upcoming meetings and sign up for the MBCP newsletter.


Meet the City's New Finance Director
