### B. Public Comments

1) Vicki Campbell, Capitola resident, said she attended this meeting to comment on a pending complaint regarding Council Member Kirby Nicol and questioned the status of the investigation. ### E. Committee Appointments

# 1) Appointment/Reappointment of Three (3) Members to the Capitola Historical Museum Board of Trustees. [110-10/240-40]

Mayor Begun introduced this item stating that the three current board members are seeking reappointment and that no other applications were received.

ACTION: Council Member Norton moved, seconded by Council Member Storey, to accept the recommendation of the Capitola Historical Museum Board and reappointed Linda Smith, Topsy Smalley, and Darcy Horton to the Board for three years, with terms to expire on the second Thursday in June, 2012. ## F. Approval of Check Register Report [300-10]

Council Member Norton questioned check #60058, Police Officers Association Dues, and #60139 to SC County Public Works. Public Works Director Jesberg said #60139 was for cooperative steel head counting in Soquel Creek with the County of Santa Cruz. He said the study was funded with monies received by Redtree Properties and The Rispin LLC and is not related to the creek monitoring program.

Mayor Begun believes check #60055 should be identified as being "funded," as it is paid for by the Capitola Village and Wharf Business Improvement Area. He also asked what dates of service Check #60065 to Charlie Howard covers for Automobile & Truck Maintenance. Staff will check into it and report back to council.

- 2. Provided the applicant, Stacie Clary, with a Grant for the Permit Fees in the amount of \$141.00.

### 4. PUBLIC HEARINGS

A. Continued Public Hearing to Consider an Ordinance Adding Chapter 17.20 to Title 17 of the Capitola Municipal Code Pertaining to an Affordable Housing Overlay (AHO) District and to Amend the City Zoning and General Plan Maps to Apply the Affordable Housing Overlay to One or More of the Following Assessor's Parcel Numbers:

034-124-20 and/or 034-124-21 (Capitola Gardens Site)

036-151-15 (600 Park Avenue Site)

036-341-02 (City-Owned McGregor Drive Site)

036-011-28 (822 Bay Avenue, Capitola Inn Site)

Presentation: Community Development Department [730-85 Zoning/740-30 LCP/740-40 General Plan]

Mayor Begun announced that the public portion of the hearing was closed at the Special Meeting of June 18, 2009; therefore, the council would not be receiving any further public testimony.

Community Development Director Goldstein provided a very brief recap of the prior hearing and responded to questions of Council Member Graves pertaining to action that was taken to remove Capitola Gardens as an opportunity site.

There were two failed motions, considerable council discussion, and then the following motion to reconsider: Council Member Nicol moved to reconsider Council Member Norton's first motion with the amendment. Council Member Graves seconded the motion. The motion carried on the following vote: AYES: Council Members Nicol, Norton, and Mayor Begun. NOES: Council Members Graves and Storey. ABSENT: None. ABSTAIN: None.

ACTION: Council Member Norton then moved, seconded by Council Member Nicol, to approve the recommended action and to include 600 Park Avenue (APN 036-151-15) and Capitola Inn located at 822 Bay Avenue (APN 036-011-28) as the city's Affordable Housing Overlay District sites, with the conditions to those sites as outlined in the submittal from Council Member Norton, and with the additional language to Section 17.20.040 pertaining to the development agreement provided by staff to be included in the proposed ordinance, as follows:

1. Passed the proposed Ordinance Adding Chapter 17.20 to Title 17 of the Capitola Municipal Code Pertaining to an Affordable Housing Overlay (AHO) District to a second reading, with the following language added to Section 17.20.040:

17.20.040 Uses Permitted with a Development Agreement:

"The following uses are permitted with the execution of a Development Agreement by the City and the developer in accordance with the provisions of California Government Code Section 65864 et seq."

- Adopted Resolution No. 3761, Resolution Authorizing Amendments to the City Zoning Map to Apply the Affordable Housing Overlay to Assessor's Parcel Numbers: 036-151-15 (600 Park Avenue) and 036-011-28 (Capitola Inn, 822 Bay Avenue); and
- 3. Adopted Resolution No. 3762, Resolution Authorizing Amendments to the City General Plan Land Use Element by Revising the Land Use Densities to Residential R-H High 10-20 Units/Acre for Assessor's Parcel Numbers: . 036-151-15 (600 Park Avenue) and 036-011-28 (Capitola Inn, 822 Bay Avenue).

The motion carried on the following vote: AYES: Council Members Nicol, Norton, and Mayor Begun. NOES: Council Members Graves and Storey. ABSENT: None. ABSTAIN: None.

### 5. OTHER BUSINESS

# A. Report on the Status of the 200 Kennedy Drive Project. [730-10: 200 Kennedy Drive; Application #07-019]

Community Development Director Goldstein and Senior Planner Bane presented this item and responded to questions of council members. Senior Planner Bane said staff has worked with the City Attorney regarding the status of the easement, and he explained how the shared access easement works. Staff responded to questions of council members.

The City Council heard from several residents of Cabrillo Mobile Estates, the park owner Albert Vieira, as well as Bob Dwyer, Mr. McCoy's partner.

Considerable Council discussion and deliberation was followed by this action:

ACTION: Council Member Norton moved to direct staff to work with Mr. McCoy, Mr. Vieira, the Homeowners' Association, and Mayor Bob Begun in resolving the two issues that are at hand: 1) Some type of screening along both Pamela's and Brenda's properties, and 2) some type of workable gate located in the proximity suggested by staff. Before a meeting takes place, staff should obtain a cost estimate for the gate and the screening. The discussion among the parties would be about how these costs would be shared. Once a resolution has been made, staff should report back to the council regarding that resolution.

Council Member Graves seconded the motion. In addition, he addressed the issue raised by mobile home park residents regarding deliveries to the site. He offered a friendly amendment to the motion that when staff prepares the deed restriction called for in the conditions, that a condition be included that would allow deliveries during normal business hours, Monday through Friday, and eliminate deliveries on Saturdays, Sundays, and holidays.

Council Member Norton said he did not think the council could add a condition to the project. Council Member Graves explained it was not a condition to the project, but an item to be added to the deed restriction that will be entered into prior to occupancy. Mayor Begun asked where that condition was located in the agenda report. Community Development Director Goldstein said it could be found on Page 3, Condition 21.

After reviewing the condition, Council Member Norton agreed that it would be appropriate to include a condition in the deed restriction pertaining to deliveries as suggested by Council Member Graves, and he accepted the amendment to the motion.

Pamela Atwood suggested that they be required to use sensor lighting that would only come on if someone were around the building. Council Member Storey suggested she talk to Mr. Bob Dwyer, since it could be a cost savings.

The motion carried on the following vote: AYES: Council Members Graves, Storey, Nicol, Norton, and Mayor Begun. NOES: None. ABSENT: None. ABSTAIN: None.

### B. Art & Cultural Commission Graphic Traffic Box Public Art Project. [1010-10]

Assistant to the City Manager Murphy summarized the written agenda report. Art & Cultural Commissioner Joyce Murphy provided a history of the project, saying it was originally brought to the Art & Cultural Commission by Debbie Hale. She then introduced artist Bruce Harman, who responded to questions of council members pertaining to graffiti.

Council discussion was followed by this action:

ACTION: Council Member Graves moved, seconded by Council Member Storey, to approve the Art & Cultural Commission Graphic Traffic Box Public Art Project and to authorize execution of the Professional Services Agreement between the City and Artist Bruce Harman, as submitted. The motion carried on the following vote: AYES: Council Members Graves, Storey, Nicol, Norton, and Mayor Begun. NOES: None. ABSENT: None. ABSTAIN: None.

  - C. Designation of Voting Delegate and Alternates for the 2009 League of California Cities Annual Conference to be held in San Jose from September 16 to 18, 2009. [150-50]

City Clerk Greeninger asked who planned to attend the League's Annual Conference. Council Member Storey and Mayor Begun said they planned to attend.

ACTION: Council Member Graves moved, seconded by Council Member Nicol, to designate Mayor Begun as the city's voting delegate, and Vice Mayor Storey as the city's alternate voting delegate, at the 2009 League of California Cities Annual Conference to be held in San Jose. The motion carried on the following vote: AYES: Council Members Graves, Storey, Nicol, Norton, and Mayor Begun. NOES: None. ABSENT: None. ABSTAIN: None.

### 6. COUNCIL/STAFF COMMUNICATIONS

Council Member Graves commented on references to administrative policies, and he wondered how those policies are approved for content and if those policies are approved by the city council. City Manager Hill said there are three different types of administrative policies: council approved policies, policies that require negotiation by employee group unions, and policies approved by staff. Council Member Graves said he was particularly concerned with policies that deal with the public the council members represent.

Mayor Begun complimented the council for working together to address two very difficult subjects on tonight's agenda. He also urged everyone to Shop Capitola.

### 7. ADJOURNMENT
