Mayor/Chairperson Begun asked if anyone wished to address items on the Closed Session agenda.

The following people addressed the City Council/Redevelopment Agency Directors pertaining to the Rispin Mansion Property Lease and Development Agreement:

Tony Gualtieri, on behalf of the Ad Hoc Capitola Library Committee, read for the record comments from the committee regarding the Redevelopment Agency/City Council Closed Session item pertaining to the Rispin Mansion Property Lease and Development Agreement. (Mr. Gualtieri submitted the comments he made orally in writing for the record. A copy is on file in Central Files: File #275-35, Rispin Development Negotiations).

Kathryn Gualtieri, Grand Avenue resident, discussed her knowledge of a property qualifying for the National Register of Historic Places and informed the City Council/Redevelopment Agency Directors that it was her professional opinion the Rispin Mansion would no longer qualify to be listed on the National Register. In closing, Mrs. Gualtieri said she believes the developers' project cannot meet the requirements of historic preservation and the project should be abandoned. (Mrs. Gualtieri submitted her comments in writing to the City Clerk for the record.) [230–10]

Michael Termini, former Council Member and current Planning Commissioner, said there was a time when he could support the project; however, given the current economy it is not a viable project for our community. He urged the council to terminate the LDA now and not to act from fear, but to act for the good of the community and stressed the importance of a decision tonight.

Nels Westman said it was painful to think of all the staff time and city resources that have been invested in this property over the years. He commented that there are many urgent needs for city and RDA tax dollars; the last thing the city should be considering is investing millions in a poorly conceived boutique B&B. Mr. Westman urged the City Council/RDA Directors not to let this drag on any further. He suggested going in a new direction that will really benefit the average resident in Capitola - a permanent library.

There being no further comments from the public, the City Council/Redevelopment Agency recessed at 6:10 p.m. to the Closed Session in the City Manager's Office.

Mayor Begun announced that he would be making a Mayor's Proclamation to Lakeside Organic Gardens, who was named "Food Industry Donor of the Year" by the Second Harvest Food Bank at their Annual Membership Luncheon on October 19, 2009. [120-40]

Presentation of Mayor's Proclamation Designating November 2009 [120-40] "Pancreatic Cancer Awareness Month"

Mayor Begun called representatives of the Pancreatic Cancer Action Network forward to receive the Mayor's Proclamation Designating November 2009 "Pancreatic Cancer Awareness Month." He read portions of the proclamation and presented it to the representatives.

Diane Morrison, 3-year pancreatic cancer survivor, discussed her situation and the need for research funding, increased awareness about pancreatic cancer, early detection and development of effective treatments and a cure. She thanked the Mayor for helping them to raise awareness in our community.

Capitola resident Jennifer Flaniken thanked Mayor Begun, and she commented on her participation in the Pancreatic Cancer Action Network, which was prompted by her father's condition.

In closing, Mayor Begun encouraged citizens to join the Pancreatic Cancer Action Network to support those patients currently battling pancreatic cancer.

Vice Mayor Storey said he was asked to perform this honor since one of the recipients is our Mayor, Bob Begun. He summarized the various 60th Birthday events planned by this group and the City's interest in recognizing those individuals for their hard work and dedication in contributing to make the City's 60th Birthday memorable.

Vice Mayor Storey called each person forward and presented each with a "Certificate of Recognition in Appreciation for Serving on the City of Capitola's 60th Birthday Committee and Contributing Significantly to the City's Sense of community and Good Fun."

Committee Member Lin Banks said City Manager Rich Hill and Assistant to the City Manager Lisa Murphy should also be recognized as they also were instrumental in contributing to the 60th Birthday events.

City Manager Hill said there were several corporate heroes who contributed to the 60th Birthday events.

Committee Member Mike Termini then presented framed photographs taken by Larry Smith on September 2, 2009, of the fireworks display to representatives of Devcon Construction and Redtree Properties, and he thanked them for their generous donations.

Craig French, on behalf of Redtree Properties, said he has received so many positive comments from members of the community regarding the fireworks display. He said Redtree Properties was happy to participate in the City's 60th Birthday by donating money for the fireworks.

Brett Sisney, on behalf of Devcon Construction, said Devcon enjoyed sponsoring the fireworks event for Capitola's 60th Birthday, which was enjoyed by the community and their employees.

1. REPORT ON CLOSED SESSION [520-25]

City Attorney Barisone said the items discussed in Closed Session were those items listed on the posted agenda. In addition, he reported that the City Council unanimously made the findings under the Brown Act to add *Los Altos/El Granada Investors vs. City of Capitola* (Castle Mobile Estates) to the Closed Session Agenda in light of the written decision received from the 9th Circuit Court of Appeals issued yesterday pertaining to that existing litigation case, which requires Council's action prior to the City Council's next regular meeting on October 22, 2009.

City Attorney Barisone then reported on the items discussed in closed session as follows:

City Attorney Barisone reported on the discussion and action taken by the City Council/Redevelopment Agency Directors pertaining to its Conference with Real Property Negotiator, Rich Hill, regarding the Rispin Mansion Property Lease and Development Agreement (LDA). He provided background information regarding this item, including extension of the LDA to September 29, 2009, following the fire that occurred at the Rispin Mansion in May. He said September 29th came and went and construction was not underway on the project. Accordingly, as of September 29, 2009, the LDA automatically terminated. He reported that in Closed Session the City Council/RDA Directors unanimously voted to direct staff to write a letter confirming that the LDA is

terminated as of September 29, 2009, and that any negotiations to reinstate the agreement would not be continued. Staff was also directed to discontinue negotiations to reinstate the agreement. He clarified that as of this time the Lease and Development Agreement is no longer binding on either party.

City Attorney Barisone reported that the City Council heard from the City Manager regarding the status of real property negotiations regarding the 4140 Jade Street property and took no reportable action in closed session.

The City Council heard from the City Attorney with respect to two items of litigation concerning Surf & Sand Mobile Home Park vs. City of Capitola. One item was a Public Records Act lawsuit in which he provided a status report. He said the court issued part of its decision last Friday and continued that matter for review on October 22, 2009. City Attorney Barisone also reported that the Surf & Sand federal court challenge to the city's park conversion ordinance, which is pending in federal court, heard an oral argument in the 9th Circuit Court of Appeal yesterday but did not rule at that time. No reportable action was taken on either of those items.

City Attorney Barisone reported that he provided the City Council with a summary of the Los Altos/El Granada Investors vs. City of Capitola (Castle Mobile Estates) decision which was added to the Closed Session agenda. The City Council provided direction to the City Attorney with regard to the further defense of that matter in the 9th Circuit Court of Appeal.

City Attorney Barisone announced that the council took the matter regarding labor negotiations off the Closed Session agenda. There was no discussion regarding that matter.

He also reported that there was no discussion regarding the tort claim of Frank Pieper and advised the matter is on the open meeting Consent Calendar for council action.

D. <u>City Council/Treasurer Comments/Committee Reports</u>

1) City Treasurer Jacques Bertrand announced that the regularly scheduled meeting of the Finance Advisory Committee for October has been cancelled and that the next meeting would be held on November 10. He announced that the Finance Advisory Committee is beginning to review individual city departments in preparation of the budget and will start with the financials of the Public Works Department.

- 2) Council Member Norton said the Santa Cruz Public Library System is in the process of developing a plan for the future. On October 13 they are holding a Town Hall Meeting at the New Brighton Middle School Performing Arts Center. The community will have an opportunity to meet Patricia Landers, the new library director, at 6:30 p.m. The town hall meeting will begin at 7:00 p.m.
- 3) Council Member Norton said, with the council's consent, he would like staff to look into a 2-tiered rent structure for Pacific Cove Mobile Home Park. It was the consensus of the council to do so.

E. Committee Appointments

1) Appointment of Youth Member to the Commission on the Environment. [430-05]

City Clerk Greeninger summarized the written agenda report and various options provided in the agenda report.

Mayor Begun asked if the Council could appoint Alyssa Stanger even though she is not a resident of Capitola. City Attorney Barisone responded stating that the council would be violating its own resolution if it was to do so, and he said the council has the authority to amend the resolution.

Council Member Norton said he had the opportunity to meet Alyssa at the Commission on the Environment meeting, and he believes she would be a real asset to the commission.

Council discussion was followed by this action:

ACTION: Council Member Norton moved, seconded by Council Member Storey, to appoint Alyssa Stanger as the Youth Member on the Commission on the Environment, and to adopt Resolution No. 3779, Resolution Amending Section 3 of Resolution No. 3696 Regarding the Youth Member on the Capitola Commission on the Environment, with an additional provision that the Youth Member be a Santa Cruz County resident.

Under discussion of the motion, Council Member Nicol said he could not support the resolution; he believes there must many young people in Capitola who could participate, and he does not think the City Council should change the law.

Council Member Graves commented on the duration of time staff has been recruiting for this vacancy and believes the proposed amendment offers the council with a solution.

The motion carried on the following vote: AYES: Council Members Graves, Storey, Norton, and Mayor Begun. NOES: Council Member Nicol. ABSENT: None. ABSTAIN: None.

2) Council Member Graves thanked City Clerk Pam Greeninger and staff for recruiting for his nomination to the METRO Advisory Committee (MAC). He received 2 applications and his nomination, Craig Agler, was appointed by the Santa Cruz Metropolitan Transit District Board on October 9, 2009.
