OPEN SESSION

1. Authorization to Recruit for the Community Development Director Position.

Mayor Nicol introduced the item and asked for staff's report.

City Manager Hill summarized the written report and the council's recent direction to initiate a limited hiring freeze, which would require Council permission to recruit for any vacancy other than in the Police Department. Since then Community Development Director Rebagliati has tendered her resignation, and staff is asking for permission to recruit for and fill the vacancy.

ACTION: Council Member Graves moved, seconded by Council Member Termini, to authorize the City Manager to recruit for the position of Community Development Director, as recommended.

Under discussion, Council Member Storey said there is no fiscal impact indicated on the staff report; however, he wondered if the city might need to augment the salary to attract qualified candidates. City Manager Hill said there is an established salary range for the position, which staff intends to use. He then responded to questions of council members.

Following discussion of the motion, the motion carried unanimously.
