#### A. 2023 Commission Goals and Priorities

Recommended Action: Consider the Commission's goals and priorities for the remainder of 2023.

Environmental Projects Manager, Erika Senyk, presented the staff report.

The Commission discussed goals and priorities for the remainder of 2023 including reviewing the City's Climate Action Plan and preparing recommendations to present to City Council in January of 2024 at the Mid-Year Budget Report meeting. The Commission considered uses for the Community Tree fund including hosting a community tree giveaway and updating the City's tree ordinance. The Commission considered using Green Building funds to enforce

The Commission requested that a Green Business Network (GBN) impact report be provided by City Staff prior to the GBN presentation at a following regular Commission meeting.

Motion to have the Green Business Network come to the September Regular Meeting of the Commission on the Environment with a 15-minute presentation and to focus on the value of the certification program to the City and Capitola businesses: Chair Beritzhoff-Law

### **B. Save our Shores Beach Public Cleanup Contract**

<u>Recommended Action:</u> Provide feedback on draft contract proposal between Save our Shores and City of Capitola for quarterly beach cleanups.

The Commission discussed the draft contract. The Commission found the trash data that Save our Shores would provide following quarterly Capitola beach cleanups warranted the cost of the annual contract and would be beneficial to the City's annual stormwater reporting purposes. The Commission did not have any suggested edits or revisions to the current draft contract between Save our Shores and City of Capitola for public beach cleanups.

The Commission requested that the following items be agendized for a future meeting:

- August 16, 2023 Regular Meeting: Discuss potential projects that support Climate Action Plan goals for the VMT and Transportation sector and the associated measures. Discuss using Community Tree funds to support an Arbor Day Foundation Tree Giveaway event.
- **September 20,2023 Regular Meeting:** Discuss potential projects that support Climate Action Plan goals for the Residential and Non-Residential Energy sector and associated measures. Receive a 15-minute presentation from a Green Business Network representative.
- October 18, 2023 Regular Meeting: Discuss potential projects that support Climate Action Plan goals for the Water and Wastewater, Solid Waste, Parks, Open Space, and Agriculture, and Action and Implementation sectors and the associated measures.
- **November 15, 2023 Regular Meeting:** Review Climate Action Plan potential projects and recommendations to bring to City Council.
- **December 20, 2023 Regular Meeting:** Approve projects and recommendations to bring to City Council at the Mid-Year Budget Report meeting in January 2024.
