#### 1. Call to Order and Roll Call

#### 2. Additions and Deletions to the Agenda

#### 3. Oral and Written Communications

- Goran Klepic, Santa Cruz County resident, spoke about the transient population at Jade Street Park being a potential sanitation issue.
- Commissioner Wilk received communications from Vice Mayor Brown and Council Member Brooks that 100 trees were distributed to residents during the 2017 Arbor Day Tree Giveaway event, however, the first day of the event would have benefited from improved coordination.

#### 5. General Business

#### A. Green Business Network Presentation

<u>Recommended Action</u>: Receive a 15-minute presentation from Green Business Network representatives regarding the City's current and potential future involvement in the program.

Green Business Network (GBN) representatives, Claudia Villalta-Mejia and Jakki Castorena-Davila, gave a presentation regarding the City's current involvement in the GBN program and additional collaboration opportunities, including business recruitment, partner connection, regional meeting attendance, City Council recognition, and other partnership opportunities.

The Commission discussed the benefits of the Green Business Network and options for continuing the City's program involvement.

Motion that the Commission sees value in the Green Business Network (GBN) for the resources and rebates the program provides, the data metrics that the program collects, and how the GBN can support the City's Climate Action Plan goals. The Commission recommends that the City promotes the GBN on social media channels and the City's website to increase awareness of the program to Capitola businesses.

#### B. Climate Action Plan goals for Residential and Non-Residential Energy

Recommended Action: Discuss potential actions and develop recommendations that support Climate Action Plan goals for the Residential and Non-Residential Energy sector and associated measures.

Environmental Projects Manager, Erika Senyk, presented the staff report.

The Commission discussed each measure of the Residential and Non-Residential Energy sector:

**ENRG – 1 Solar Energy:** Commission recommends prioritizing assessing solar energy as a way to power EV infrastructure within the City, given the limitations of Pacific Gas and Electric infrastructure for residential and non-residential areas in Capitola. Commission also recommends prioritizing identifying locations for solar farms within the City, which can help to inform permitting and municipal planning processes.

**ENRG – 2 Energy Upgrade California and Residential Energy Efficiency:** Commission recommends additionally prioritizing researching energy saving materials and avenues through which the City can provide those materials to residents (e.g., energy-efficient light bulb giveaway event). The Commission agreed to discuss at a later meeting future energy needs related to climate planning and how the City will respond to natural disasters (e.g., energy efficient backup generators).

**ENRG – 3 Residential Weatherization:** The Commission did not have comments on this measure at this time.

**ENRG – 4 Renewable Energy Sources and Community Choice Aggregation:** The Commission did not have comments on this measure at this time.

**ENRG – 5 Non-Residential Energy Efficiency:** The Commission did not have comments on this measure at this time.

**ENRG – 6 Right Lights Energy Efficiency Program:** The Commission recommends that the City research whether the Right Lights Energy Efficiency Program is still current and that the new Climate Action Plan include an updated scope of relevant programs.

**ENRG – 7 Green Business Certification Program:** The Commission agreed to move a discussion of the idea of promoting an individual environmental certification as part of the new Climate Action Plan to the November Commission on the Environment regular meeting.

**ENRG – 8: Municipal Energy Use:** The Commission did not have comments on this measure at this time.

The Commission plans to bring additional comments regarding the Residential and Non-Residential Energy sector to the November 15<sup>th</sup>, 2023 regular COE meeting.

- **December 20, 2023 Regular Meeting:** Approve projects and recommendations to bring to City Council at the Mid-Year Budget Report meeting in January 2024.
- **Green Building Funds:** Discuss Green Building funds and potential recommended uses of the funds in support of the City's Climate Action Plan goals.
