A. Approval of Minutes - Meetings of April 18, 2023, and May 2, 2023

Minutes of April 18th moved by Chairperson Coffman, seconded by Councilmember Pedersen. Minutes of May 2nd moved by Vice Mayor Brown, seconded by Chairperson Coffman.

B. Discussion regarding FY 2023-24 Proposed Budget

Staff provided an update on the FY 2023-24 Proposed Budget which included an overview of ongoing revenues and expenditures, an update on the general and reserve fund balances, and 5-year budget forecast. Staff also provided the following summary of changes since the FAC meeting of May 2nd:

- Equipment ISF purchases:
 - Hybrid Van Recreation \$53,000
 - EV Utility truck & Crane PW \$90,000
 - 3/4 Ton 4X4 Truck PW \$51,000
 - EV Admin Vehicle PD \$60,000
- Police Dept. reorganization personnel costs reduced \$20,600.
- Information Technology ISF increased \$30,000 PW.
- City Council Recognition and Awards increased \$5,000 volunteer appreciation dinner.
- Recreation increased \$6,700 Training & Supplies
- Wharf Fund increased \$17,500 Project enhancement design costs.

Staff also discussed several non-fiscal amendments to the proposed budget to provide additional information and transparency.

The committee reviewed the FY 2023-24 Proposed Capital Improvement Budget summarized below:

- Prior Year Appropriations \$14.4 million 11 projects
- Recommended FY 2023-24 Appropriations \$3.2 million 4 projects
- Additional projects
 - Storm Damages \$2.5 million 15 projects
 - City Council Goals \$350,000 7 projects

The Committee recommended that the City Council designate the remaining \$178,000 of undesignated general funds towards future major infrastructure projects to bring the total designation to \$978,000.
