1. CALL TO ORDER AND ROLL CALL

Acting Board President Dave Peyton called the Regular Meeting of the Capitola Historical Museum Board of Trustees to order at 5:32 p.m. on Thursday, February 2, 2023, in the Capitola City Hall Council Chambers, 420 Capitola Avenue, Capitola, CA, and online via Zoom.

2. ORAL COMMUNICATIONS

- A. As there was no board meeting in January due to the storms, and after two postponements, the Curator decided to hold the next Board Meeting as scheduled on February 2, 2023.
- B. Community member Niels Kisling voiced concerns regarding the Frank Hill murals and a vintage Capitola Begonia Festival poster (name of correct donor and contact information needed to send a thank you). After discussion Curator Osterberg duly noted his concerns stating that over the past couple of months she has spent Museum funds to have several of the murals framed. Since they are from the Soquel Post Office, most do not depict Capitola scenes and two murals may be better suited to be given to the new Summit Museum currently being developed. No action has yet been taken on this other than framing the artwork.
- C. A discussion regarding the cataloging and clarifying documentation of our whole collection ensued regarding hiring help, which is not yet required. Deborah gave a brief explanation that the scope of her understanding regarding events, activities, public requests and need for information delay proper cataloging, etc. Newspaper (monthly "Focal Point", other Museum outreach and events are vital for interaction. Emmy offered to attend meetings in her place and Dave wants to be sure the City of Capitola realizes the full scope of her position. Deborah noted that Chloe, assistant to the City Manager, allows additional hours this time of the year.
- D. At this time Business 5 A. Swearing in of new Board members apointed by the Capitola City Council was relocated in the agency (due to one of the prospective members having to leave early) with Acting President Dave Peyton having Enrique Dolmo, Jr. And Roger Wyant repeating the Oath of Office.
