Signature on said Bid Form indicates acknowledgement of receipt of Addendum No. 2, and that said Addendum No. 2 was properly evaluated in bidder's proposal. Any proposal not in compliance with this requirement may be rejected.

Notice Inviting Sealed Bids: The bid opening is hereby delayed. Bid proposals will due to the Director of Public Works of the City of Capitola, County of Santa Cruz, State of California by **11:00 a.m. on Wednesday, April 15, 2020** at the City of Capitola, City Hall, 420 Capitola Avenue, Capitola, California.

The required documents for the bid submittal shall be changed to include only pages 5-23 plus all addendums to the Special Project Specifications. All other pages of the specifications can be omitted

from the bid proposal documents.

All bid proposals shall be submitted in a single sealed envelope plainly endorsed: **Brommer Street Complete Street Improvement Project**. Bid proposals will be opened publicly and read aloud on **Wednesday, April 15, 2020 at 11:00 A.M.** at the City of Capitola, City Hall, 420 Capitola Avenue, Capitola, CA 95010.

BID PROPOSAL:

The City will award the contract to the lowest responsible bidder complying with the instructions in the Notice Inviting Sealed Bids. <u>The lowest bidder will be determined on the basis of the total of the Base</u> <u>Bid (Schedule A) solely.</u> Add Alternative 1 (Schedule B) will be added to the contract at the City's discretion. It will be considered to be added based on costs and available funding. In the event that the product of a unit price and an estimated quantity does not equal the extended amount quoted, the unit price shall govern, and the corrected product of the unit price and the estimated quantity shall be deemed to be the amount bid. If the sum of two or more item totals in the bid schedule does not equal the total amount bid, the individual item totals shall govern, and the corrected sum shall be deemed to be the amount bid.

The City reserves the right to award a contract for the Base Bid (Schedule A) only or the Base Bid (Schedule A) plus Add Alternative 1 (Schedule B) on the bid proposal page subject to the available funds at the time of the award.
